Whereas, the WRC had granted the recognition to Aryavart Shiksha Mahavidhyalaya, (Run by Adityavart Mahila Samiti), 12/C Sec-IV, Plot No. 675, Ruabandha, UTAI Avenue - A, Sector-VI, Indira Place, Bhilai, Durg, Chhattisgarh-490006 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2009-2010 vide order No. WRC/5-6/121st/2009/57489 dt. 13.07.2009.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Adityavart Mahila Samiti, Bhilai, Durg, Chhattisgarh offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 14.01.2015 from the institution, a revised recognition order no. WRC/APW08065/723180/2015/138946 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students each) from the session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014:-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255th meeting held on June 22-24, 2016 and Committee decided to issue Show Cause Notice dt. 22.08.2016.

And whereas, reply dt. 09.09.2016 and 24.06.2015 was submitted by the institution was placed before the WRC in its 290th meeting held on March 21st - 23rd, 2018 and the Committee decided as follows :-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice was issued on 22.08.2016. The institution replied on 09.09.2016.

The institution has submitted a list of 1+15 faculty members which is not approved by the Registrar.

The Building Completion Certificate submitted but built-up area is not sufficient as per requirement of NCTE Regulations, 2014.

The additional FDR for Rs.4.00 lakhs not submitted (in joint name) in original.

Hence, Recognition is withdrawn from the end of the next academic session."

Now, therefore, the recognition of Aryavart Shiksha Mahavidhyalaya, (Run by Adityavart Mahila Samiti), 12/C Sec-IV, Plot No. 675, Ruabandha, UTAI Avenue - A, Sector-VI, Indira Place, Bhilai, Durg, Chhattisgarh-490006 for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.
