**ORDER**

WHEREAS, in terms of section 14 (3) (a) of the NCTE Act 1993, WRC had granted recognition to Smt. Shariben Shukla Mahila B.Ed. And Whereas, the institution was granted permission for change of premises from Smt. Shariber Shukla Mahila B.Ed. College, Parth Complex, Mahemdabad Kheda, Gujarat to Smt. Dhariben Shukla Mahila B.Ed. College, 190, 191/1-2-3, 192/1-2 of Mouje Mahemdabad, Kheda, Gujarat vide order no. WRC/5-6/APW00573/323170/142<sup>nd</sup>/2010/72291-72296 dated 04.12.2010.

And Whereas, WRC issued revised recognition order to Smt. Dhariben Shukla Mahila B.Ed. College, Run by Hariba Kelavani Trust, 190, 191/1-2-3, 192/1-2 of Mouje Mahemdabad, Kheda, Gujarat vide order no.WRC/APW00573/323170/2015/143885/90/98/903/906/910/913/916 dated 31.05.2015 for conducting B.Ed. course of two year duration with an annual intake of 100 students (two basic unit of 50 students each) from the academic session 2015-2016.

And Whereas, the institution applied for change of Univeristy from SNTD Women's University, Mumbai to Sardar Patel University, Vallabh Vidyanagar, Gujarat and also change of mode of Course from Girls to Co-Ed.

It has also requested for crange of course mode from girls to Co-ed.The institution has submitted a resolution passed by the Society to this effect. NOCs from SNTD Women's University and Sardar Patel University have also been submitted.
