Whereas in terms of Section 15 of the NCTE Act, 1993, Grow More Foundation, Street/Road — Ahmedabad Udaipur Highway, Village/Post office — Himatnagar, Tehsil/Taluka — Himatnagar, District — Sabarkantha-383001, Gujarat. had submitted the application on 23.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Grow More College of Education, Plot Number — Committee of the NCTE for grant of recognition to Grow More College of Education, Plot Number — 1003/641, 435/2, Street/Number — National h, Village/Post office — Berna, Tehsil/Taluka — 1003/641, 435/2, Street/Number — National h, Village/Post office — Berna, Tehsil/Taluka — Himatnagar, District — Sabarkantha-383001, Gujarat .for B.A. B.Ed./B.Sc. B.Ed. (Integrated)-04 years course for the academic session 2016-2017.

And whereas, the proposal was examined and the Show Cause Notice was issued to the institution on 09.02.2016, and reply was submitted by the institution, was received on 14.03.2016.

And whereas, the reply of SCN was placed in  $247^{th}$  meeting held on 04 -  $06^{th}$  April, 2016 and the Committee decided VT be constituted.

And whereas, the inspection of institute was conducted on 15.04.2016.

And whereas, the visiting team report along with other document, was placed before the WRC in its 249<sup>th</sup> meeting of WRC and Committee decided to issue Letter of Intent (LOI) for one unit of B.A. B.Ed. and one unit of B.Sc. B.Ed. course. Accordingly, letter of intent was issued on 26.04.2016.

And whereas, reply of letter of intent dated 01.05.2016, was placed before the WRC in its 251<sup>st</sup> meeting held on 30<sup>th</sup> April-02<sup>nd</sup> May, 2016 and Committee decided to issue Show Cause Notice. Accordingly Show Cause Notice was issued on 05.05.2016.

And whereas, the reply of SCN was placed in  $257^{th}$  meeting held on  $02^{nd}$  –  $04^{th}$  August, 2016 and the Committee decided to issue Show Cause Notice on following grounds:-

"LOI dt. 26/04/2016 was issued. The following lacunae are seen in the documents submitted by the applicant institution :-

- i) The staff profile is signed by the Registrar of Hemachandracharya North Gujarat University, Patan in which it is written that 'subjected to approval of the LIC and EC'. This list is not in original, it is a photocopy;
- The scrutiny of this list shows that the marks of the following lecturers are less than what is required as per Appendix-13 as per the of the NCTE Regulations, 2014 Assistant Lecturers at serial Nos. 6,7,and 11;
- iii) The Principal's experience has also not been submitted; and
- iv) FDRs have also not been submitted.

Since, the institution has failed to complete the formalities necessary after issue of LOI in spite of Show Cause Notice dt. 07/05/2016, **Recognition is refused..**"
