**Refusal Order**

Whereas in terms of Section 15 of the NCTE Act, 1993, Bhagyodaya Education and Charitable Trust, Plot Number – 190, Street/Road – Rajkot Morbi National Highway, Village – Hadala, Post office – Hadala, Tehsil/Taluka – Tankara/Morbi/Rajkot, District – Rajkot, Gujarat – 363650 had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Arpit College of Education, Plot/Khasara No. – R.S. No. 190, Plot Number – 190 paiki 1and2, Street Number – Morbi Road, Village – Hadala, Post office – Hadala, Tehsil/Taluka – Tankara/Morbi/Rajkot, District – Rajkot (GJ), Gujarat – 363650 for M.Ed. 02 years course for the academic session 2016-2017.

And whereas, the proposal was examined and the Show Cause Notice was issued to the institution on 09.02.2016, and reply was submitted by the institution, was received on 08.03.2016.

And whereas, the reply of SCN was placed in 247<sup>th</sup> meeting held on 04 - 06<sup>th</sup> April, 2016 and Committee decided to refuse recognition to the institution on the following points:-

"Show Cause Notice was issued to the institution on 09/02/2016 on the following grounds:-

- NOC from the affiliating body not submitted;
- Certified copy of registered land documents not submitted;
- Notarized copies of CLU, Building Completion Certificate, and Non-Encumbrance Certificate not submitted;
- Copy of documentary proof of NAAC application not submitted.

The institution replied vide letter 04/03/2016. It is seen that the institution has not submitted the required documents except for notarized copies of Building Completion Certificate and Non-Encumbrance Certificate.

**Hence, Recognition is refused. FDRs if any, be returned."**

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of the NCTE Act, 1993, **the Western Regional Committee hereby refuses recognition to Arpit College of Education, Plot/Khasara No. – R.S. No. 190, Plot Number – 190 paiki 1and2, Street Number – Morbi Road, Village – Hadala, Post office – Hadala, Tehsil/Taluka – Tankara/Morbi/Rajkot, District – Rajkot (GJ), Gujarat – 363650 for M.Ed. course**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
