WITHDRAWAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **KHALSA MINORITY TRUST, VILLAGE- 49, STREET/ROAD- VIKAS NAGAR, TALUKA/MANDAL- GWALIOR, TOWN/CITY- GWALIOR, DISTRICT- GWALIOR- 474001, MADHYA PRADESH** had submitted the online application on **30.06.2016** to the Western Regional Committee of the NCTE for grant of recognition to **GURU HARGOVIND SINGH SHIKSHA MAHAVIDHYALAYA, SURVEY NO. 1815/2/3, VILLAGE- BAGOTA, STREET/ROAD- CHHATARPUR, TALUKA/MANDAL- CHHATARPUR, TOWN/CITY- BAGOTA, DISTRICT- CHHATARPUR- 471405, MADHYA PRADESH** for starting the B.ED. Course.

AND WHEREAS, the application of the institution was processed.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 05.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, as per directed by WRC, in its 266th Meeting held on January 10-12, 2017, it was decided that: "The WRO should process all the files and send VT to all institutions which fulfill all the requirements as per Regulations. Show Cause Notice can be issued to all institution which have not submitted a valid up to date CLU with payment receipts. The rest of the applications should be put up to the WRC for disposal."

AND WHEREAS, the Show Cause Notice was issued to the institution through online on 17.02.2017 and the reply was received on 08.03.2017 & 09.03.2017 alongwith Court order dated 30.01.2017 of Writ Petition No. 412/2017 respectively filed in the Hon'ble Court of Madhya Pradesh Bench at Gwalior.

AND WHEREAS, the reply was placed in 272nd Meeting held on April 06-08, 2017 of WRC and the Committee decided that "...Show Cause Notice was issued to the institution on 16/02/2017 and reply received on 09/03/2017.

Since the institution has submitted all the required documents, VT be constituted."

AND WHEREAS, the inspection letter was sent to the institution through online on 08.04.2017 and the inspection conducted of the institution on 17.04.2017 and VTR received in office on 21.04.2017.

AND WHEREAS, the matter was placed in 274th Meeting held on April 27, 2017 of WRC and the Committee decided that "...The VT visited the institution on 17/04/2017. The CD was seen and VTR perused. The CD shows a building with adequate instructional and infrastructural facilities. The VT has recommended the case.

Hence, LOI be issued for 2 units of the B.Ed. course.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

AND WHEREAS, the Letter of Intent under Clause 7(13) of the NCTE Regulations, 2014 was issued on 29.04.2017 and the reply received on 02.05.2017.

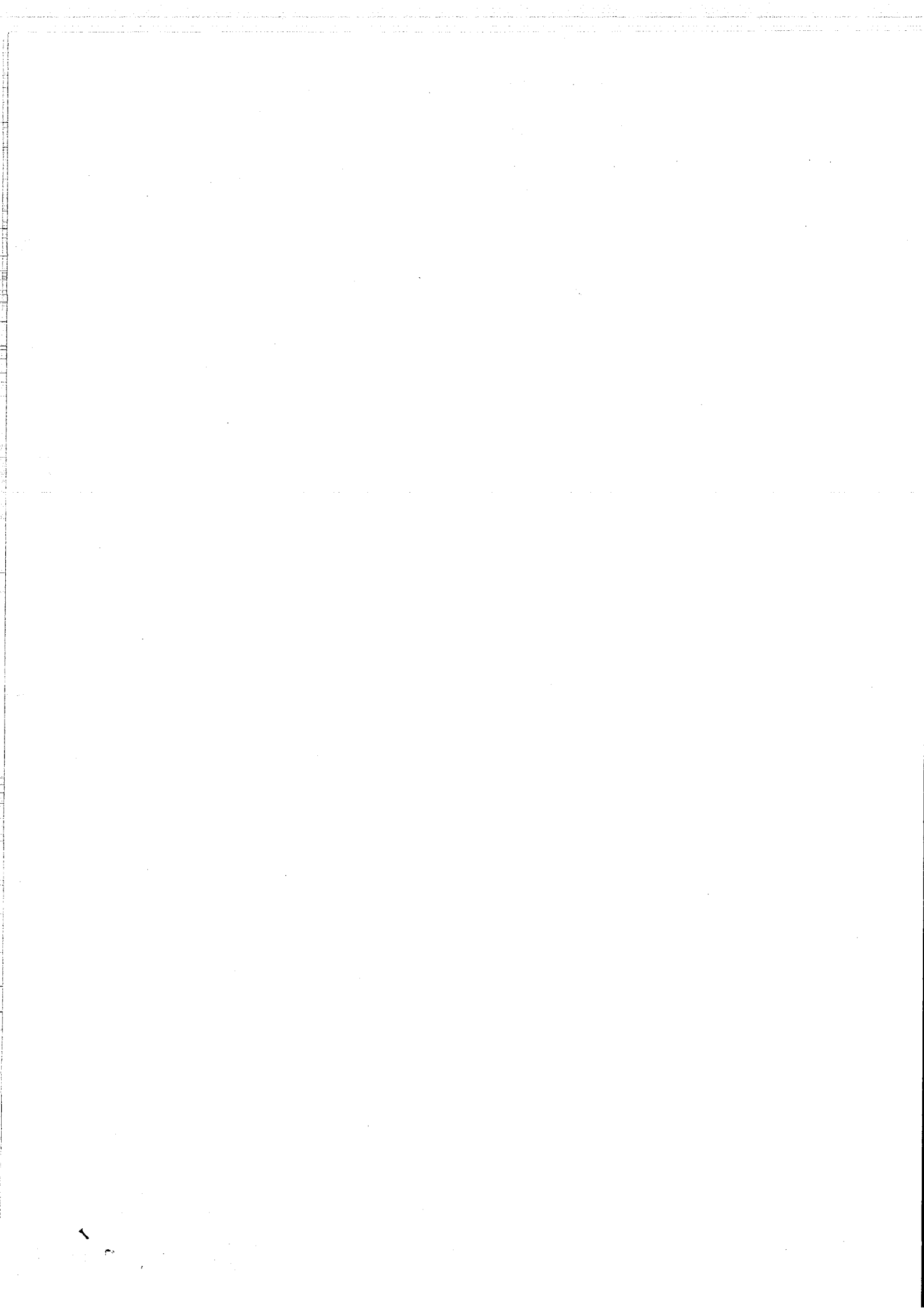

AND WHEREAS, the reply was placed in 275th Meeting held on May 01-02, 2017 of WRC and the Committee decided that "...Consequent to the issue of LOI, the institution has submitted a list of 1 Principal and 15 faculty members who are qualified and approved by the competent authority.

Hence, Recognition be granted for 2 units of the B.Ed. course from the academic session 2017-2018."

AND WHEREAS, the Recognition order was issued to the institution on 05.05.2017.

AND WHEREAS, WRC had received a complaint on 24.05.2017 & 25.05.2017 from Shri Pawan Pratap Singh, Bureau Chief in Dainik Vijaymath, Chhatarpur against the institution applied to grant recognition by presenting fake documents and non-existence of land and building.

AND WHEREAS, the reply was placed in 276th Meeting held on May 30-31, 2017 of WRC and the Committee decided in **D.El.Ed. course (APP201660248)** that "... A complaint is received from Bureau Chief, Chhatarpur in Dainik Vijaymath. The WRC decided to do following:-

- a) Send the complaint together with the supporting documents to Guru Hargovind Singh Shiksha Mahavidhyalaya, Chhatarpur for para-wise reply.
- b) Send the complaint together with the supporting documents to the Collector/SDM, Chhatarpur for enquiry into the alleged fraud.
- c) Send the land documents to the sub-Registrar Chhatarpur for verification and validity of the documents.
- d) Send the relevant documents and photographs to the Principal, Vijay Adhunik Uchhtar Madhyamik Vidhyalaya Chhatarpur to reply to the allegation that the inspection for the proposed College took place in the premises of School.
- e) Send the relevant documents and photographs to the DEO, Chhatarpur for enquiry.

Till the enquiry is completed and reports submitted, no admissions shall be made in both B.Ed. and D.El.Ed. courses. The affiliating bodies be informed accordingly."

AND WHEREAS, letter was sent to the Institution on 08.06.2017 regarding complaint received against it and reply not received from the institution to till date.

AND WHEREAS, letter was sent to the **Sub-Registrar** on 08.06.2017 for the verification & validation of the Land documents and reply not received from the institution to till date.

AND WHEREAS, letter was sent to the **Principal, Vijay Adhunik Uchhtar Madhyamik Vidhyalaya, Chhatarpur** on 08.06.2017 to reply against the allegation and reply not received to till date.

AND WHEREAS, letter was sent to the **District Education Officer, Chhatarpur** on 08.06.2017 to send the relevant documents & photographs for enquiry and reply not received to till date.

AND WHEREAS, letter was sent to the **Registrar, Maharaja Chhatrasal Bundelkhand University, Chhatarpur** and a copy of the same was sent to the **Secretary, Department of Higher Education, Bhopal** on 08.06.2017 to conveying the decision of 276th WRC meeting and reply not received to till date.

AND WHEREAS, letter was sent to the Collector and a copy of the same was sent to the SDM, Chhatarpur on 08.06.2017 and the reply not received from the Collector to till date but only an information letter received from the SDM, Chhatarpur on 21.06.2017 & 23.06.2017.

AND WHEREAS, Reminder letter- I was sent to the Senior Sub-Registrar on 19.07.2017 for the verification & validation of the Land documents and reply not received from the institution to till date.

AND WHEREAS, Reminder letter- I was sent to the Collector, Chhatarpur on 19.07.2017 and the reply not received to till date.

AND WHEREAS, Reminder letter- I was sent to the District Education Officer, Chhatarpur on 19.07.2017 to send the relevant documents & photographs for enquiry and reply not received to till date.

AND WHEREAS, Reminder letter- I was sent to the Registrar, Maharashtra Chhatrasal Bundelkhand University, Chhatarpur & a copy was sent to the Secretary, Department of Higher Education, Bhopal on 19.07.2017 but reply not received to till date.

AND WHEREAS, the matter was placed in 278th Meeting held on July 25-26, 2017 of WRC and the Committee decided in D.El.Ed. Course (APP201660248) that "...The WRO vide letter dt. 08.06.2017 had asked the Raja Shiksha Kendra not to allocate students for the D.El.Ed. course till the complaint is resolved.

Subsequently, the Raja Shiksha Kendra vide letter dt. 20.07.2017 had enclosed a letter of WRC no. 187493 dt. 11.07.2017 asking that the name of the College be included for counseling. This forged letter was received by Raja Shiksha Kendra from the institution.

Hence, Show Cause Notice be issued to the institution as to how this forged letter from WRC was obtained and submitted to Raja Shiksha Kendra."

AND WHEREAS, the Show Cause Notice was issued to the institution in D.El.Ed. Course (APP201660248) on 31.07.2017 and the reply received on 30.08.2017.

AND WHEREAS, a letter received from the SDO, Chhatarpur on 21.09.2017.

AND WHEREAS, letter regarding verification of the Minority Certificate was sent to the National Commission for Minority Educational Institutions, New Delhi on 09.08.2017, vide letter dated 19.09.2017 has confirmed the minority status to only seven of these sixteen institutions.

AND WHEREAS, the Minority Certificate has not been issued by the Commission to the institution.

AND WHEREAS, the matter was placed in 282nd Meeting held on October 24-26, 2017 of WRC and the Committee decided that "... In response to complaint received on 24.05.2017, the case was referred to the Collector/SDM, Chhatarpur. Since there were two conflicting reports from the same SDM, both the reports were referred to the Collector/SDM. The SDM, Chhatarpur had confirmed that the first report dated 13.06.2017 should be considered as the valid report.

Since, this report is negative with regard to documents, infrastructure etc., Recognition is withdrawn with immediate effect.

NOW, THEREFORE, the recognition granted to **Guru Hargovind Singh Shiksha Mahavidhyalaya, Survey No. 1815/2/3, Village- Bagota, Street/Road- Chhatarpur, Taluka/Mandal- Chhhatarpur, Town/City- Bagota, District- Chhatarpur- 471405, Madhya Pradesh** for conducting B.Ed. course vide order dated **05.05.2017** is hereby immediately withdrawn under section 17/(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing of appeal may be seen on NCTE website.
