REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, **INDIRA GANDHI NATIONAL TRIBAL UNIVERSITY, VILLAGE: PODKI LALPUR, KHASRA NO. 136-217, 658-662, 664-678, 679/2, 680-684, 180/715, 201/716-718, P.O.: AMARKANTAK, TEHSIL: RAJENDRAGRAM, CITY: AMARKANTAK, DIST.: ANUPPUR 484886, MADHYA PRADESH (226002/B.A.B.Ed. & B.Sc.B.Ed.)** had submitted the application on **07.11.2012** to the Western Regional Committee of the NCTE for grant of recognition/permission to **INDIRA GANDHI NATIONAL TRIBAL UNIVERSITY, VILLAGE: PODKI LALPUR, KHASRA NO. 136-217, 658-662, 664-678, 679/2, 680-684, 180/715, 201/716-718, P.O.: AMARKANTAK, TEHSIL: RAJENDRAGRAM, CITY: AMARKANTAK, DIST.: ANUPPUR 484886, MADHYA PRADESH** for **B.A.B.Ed. & B.Sc.B.Ed. 4 years integrated course.**

AND WHEREAS, in 214th meeting of the WRC held on January 19-20, 2015, it was decided "*...It is observed that course curriculum of four year B.A. B.Ed. and B.Sc. B.Ed. has been approved by the NCTE hqrs. The NCTE hqrs has requested that the application for the University be processed since it has now become main stream programme. Central Universities have relaxation of three years with respect to land and infrastructure requirements.*

The affidavit of the University consenting to function under the NCTE Regulations, 2014 is still awaited. Hence VT be sent as soon as the affidavit is received."

AND WHEREAS, the Visiting Team visited the institution on 10.04.2015.

AND WHEREAS, the visiting team report alongwith other documents, were placed before WRC in its 223rd meeting held on April 23-24, 2015. The Committee decided that "*...The CD was seen and The VT report was perused. The CD shows a good building with infrastructural and instructional facilities as per NCTE Norms. The VT has also recommended the case.*

Hence LOI under Clause 7(13) of NCTE Regulations, 2014, be issued.

*The Management also be advised to complete the formalities required after issue of LOI by 20.05.2015 as per Appendix-4 of NCTE Regulations, 2014. If these formalities are completed well before 20.05.2015, **Recognition** can be considered for the academic session 2015-2016. Otherwise, the case will be considered for the academic session 2016-2017."*

AND WHEREAS, the LOI was issued on 28.04.2015.

AND WHEREAS, the reply of LOI not submitted by institution was placed before WRC in its 236th meeting held from December 15-16, 2016. The Committee decided that:- "*...LOI dated 28.04.2015 was issued, but no reply has been received regarding any action taken to complete the formalities required after issue of LOI. Hence, **Show Cause Notice be issued on this ground.***"

AND, WHEREAS, the Show Cause Notice was issued on 04.01.2016.

AND WHEREAS, the reply dt. 28.01.2016 of Show Cause Notice was placed before WRC in its 241st meeting held on February 4-6, 2016. The Committee decided that "...LOI dt. 28/04/2014 was issued. The case was then seen in 236th meeting (15-16, December, 2015). Since the institution had not submitted any reply, after issue of LOI, Show Cause Notice dt. 04/01/2016 was issued. Vide letter dt.28/01/2016, the University has informed that recruitment work is in progress, and the status of LOI be maintained. This is a Central University.

The University be informed that only if all the formalities necessary after issue of LOI are completed by 3rd March, 2016, the case will be considered for Recognition from 2016-2017. After 3rd March, 2016 the case will be considered for the next session."

AND, WHEREAS, the Letter was issued on 18.02.2016.

AND WHEREAS, the reply dt. 29.11.2016 of Letter of Intent was placed before WRC in its 265th meeting held on December 27-29, 2016. The Committee decided that "...The institution has submitted application for the B.A.B.Ed. and B.Sc.B.Ed. courses (Code-226002) and for the M.Ed. course APP2591. The staff profile has been submitted for both of these courses which are identical.

As per NCTE Regulations, 2014, Appendices 4 and 5, the requirement is 1 Principal/HOD and 7 faculty members, for the B.A.B.Ed. course and a similar figure for the B.Sc.B.Ed. course. It means that 16 staff members are required for the B.A.B.Ed. and the B.Sc.B.Ed. courses.

*Further, for the M.Ed. course, the requirement is 2 Professors, 2 Associate Professors, and 6 Assistant Professors. The institution has in all 12 faculty members. This list is not sufficient for running the 3 courses. **Hence, Show Cause Notice be issued on the above grounds. Reply should be received within 30 days."***

AND WHEREAS, the Show Cause Notice was issued on 03.01.2017.

AND WHEREAS, the matter of reply not received was placed before WRC in its 289th meeting held on March 1 & 3, 2018. The Committee decided that "...The University was asked to fulfill the staff requirement vide LOI dated 28.04.2015 followed by a Show Cause Notice dated 03.01.2017. No reply has been received till date. **Hence, Recognition is refused."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to **INDIRA GANDHI NATIONAL TRIBAL UNIVERSITY, VILLAGE: PODKI LALPUR, KHASRA NO. 136-217, 658-662, 664-678, 679/2, 680-684, 180/715, 201/716-718, P.O.: AMARKANTAK, TEHSIL: RAJENDRAGRAM, CITY: AMARKANTAK, DIST.: ANUPPUR 484886, MADHYA PRADESH** for the **B.A.B.Ed. & B.Sc.B.Ed. 4 years** integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
