Order

WHEREAS, in terms of under section 15 of the NCTE act 1993, recognition/permission was granted to the institution, namely, **PT. BRIJKISHORE PATERIA COLLEGE OF EDUCATION, SURVEY NO: 221/1, 221/6, 221/7, 69/3, VILLAGE: DEORI, STREET/ROAD: KHANDERAO WARD, TALUKA/MANDAL: DEORI, TOWN/CITY: DEORI, DISTRICT: SAGAR-470226, MADHYA PRADESH** for conducting **B.A.B.Ed.** 4 years integrated course vide order dated **05.05.2017** for an annual intake of 50 students.

AND WHEREAS, the institution preferred an appeal before the council (NCTE) U/S 18 of the NCTE act, 1993, against the recognition order dated 05.05.2017 and the council vide order dated 29.11.2017 remanded the case to the WRC, NCTE for considering the request of the appellant institution for grant of one unit of B.Sc.B.Ed. in lieu of B.A.B.Ed. programme subject to the condition that suitable faculty is appointed with the approval of affiliating University and the conditions laid down in para 1.1. of Appendix 13 are fulfilled.

AND WHEREAS, the aforesaid appeal order was placed before the WRC in its 286th meeting held on January 16-17, 2018 and the committee decided that "...This is a case of appeal. In accordance with the appeal order, the institution be informed that it should submit staff profile for B.Sc.B.Ed. course. Thereafter the WRC will consider the case further. Hence, clarification be sought from the institution. Reply should be submitted within one month." Accordingly, Clarification letter was issued to institution on 23.01.2018.

AND WHEREAS, the reply dated 28.02.2018 submitted by the institution was placed before WRC in its 289th meeting held on March 01 & 03, 2018 and the committee decided as follows "...In response to the clarification letter dated 23.01.2018, the institution vide reply dated 28.02.2018 has submitted a list of 1+15 faculty members, who are qualified and approved by the competent authority. In supersession of earlier order, the institution is granted recognition for one unit of B.A. B.Ed. course and one unit of B.Sc.B.Ed. course."

NOW, THEREFORE, in exercise of the powers vested under **Section 15 (3) (a)** of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition/permission to **PT. BRIJKISHORE PATERIA COLLEGE OF EDUCATION, SURVEY NO: 221/1, 221/6, 221/7, 69/3, VILLAGE: DEORI, STREET/ROAD: KHANDERAO WARD, TALUKA/MANDAL: DEORI, TOWN/CITY: DEORI, DISTRICT: SAGAR-470226, MADHYA PRADESH** for conducting **B.A.B.Ed. & B.Sc.B.Ed.** integrated programme of **4 (Four) years** duration with an annual intake of **100 students (One basic unit of 50 students each)** from the academic session **2018-19**.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

The institution shall fill the GIS information on the NCTE website within one month from the date of this order.

The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter:
- d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Note: Recognition order issued vide order no. WRC/APP201660074/8811/B.A.B.Ed. /MP/275th/2017/185380-185387 dated 05.05.2017 may be treated as cancelled from the academic session 2018-19.
