REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, **SMT. DURGA DEVI SHARMA NYAS HOSHANGABAD, KHASRA NO. 101/4, VILLAGE: BUDHWADA, STREET/ROAD: HARDA BYPASS, TALUKA/MANDAL + TOWN/CITY: HOSHANGABAD, DISTRICT: HOSHANGABAD - 461001, MADHYA PRADESH (APP201660102/B.A.B.Ed.)** had submitted the application on **31.05.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to **PT. RAMLAL SHARMA COLLEGE OF EDUCATION, KHASRA NO. 101/4, VILLAGE: BUDHWADA, STREET/ROAD: HARDA BYPASS, TALUKA/MANDAL + TOWN/CITY: HOSHANGABAD, DISTRICT: HOSHANGABAD-461001, MADHYA PRADESH** for **B.A.B.Ed. 4 years integrated course.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 16.08.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 264th meeting of the WRC held on December 14-15, 2016 it was decided as under:-

"The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

AND WHEREAS, the Visiting Team visited the institution on 18.03.2017.

AND WHEREAS, the visiting team report alongwith other document, were placed before WRC in it's 272nd meeting held on April 06-08, 2017. The committee decided that:-

"...The VT visited the institution on 18/03/2017. The VTR was perused but the CD could not be viewed as it was received in a damaged condition. The institution is required to submit another viewable CD. Hence, Clarification be obtained on the above grounds." Accordingly Clarification letter was issued to the institution on 13.04.2017 through online mode.

AND WHEREAS, the reply dt. 28.04.2017 of the Institution was placed before WRC in its 275th meeting held on May 1-2, 2017. The Committee decided that "...The VT visited the institution on 24/04/2017. The CD was seen and VTR perused. The CD shows a building with adequate instructional and infrastructural facilities. The VT has recommended the case.

However before further action can be taken, the institution needs to clarify the following:-

- As per CLU, the total land area is only 2405 sq. mtrs. which is insufficient to run the existing 2 units of B.Ed. and the proposed 1 unit of B.A.B.Ed./B.Sc.B.Ed.
- The Building Completion Certificate is not signed by a Govt. Engineer.
- Non-Encumbrance Certificate has not been submitted.

The institution should clarify which course it wants to run B.A.B.Ed. or B.Sc.B.Ed. Both cannot be run simultaneously in view of the NCTE Hqrs. letter dt. 31/03/2016 which states that "B.A./B.Sc.B.Ed. (Integrated Programme) is one programme and is governed by Appendix-13 of the NCTE Regulation 2014. The Programme cannot be segregated into two programmes with two different nomenclatures, and sanction of two units each..." **Hence, Show Cause Notice be issued to the institution on the above grounds.** Accordingly Show cause notice was issued to the institution on 18.05.2017 through online mode.

AND WHEREAS, the reply dt. 12.06.2017 of the Institution was placed before WRC in its 283rd meeting held on November 14-15, 2017. The Committee decided that "...In response to the Show Cause Notice, the institution has submitted the relevant documents. **Hence, LOI be issued for one unit of B.A. B.Ed. course.**"

AND WHEREAS, the Letter of intent was issued on 21.11.2017

AND WHEREAS, the reply dt. 29.01.2018 of the Institution was considered by WRC in its 288th meeting held on February 15-16, 2018. The Committee decided that "...Consequent to the issue of LOI dated 21.11.2017, the institution has not yet submitted the staff profile approved by the Registrar in the official NCTE format. The institution has also not submitted the required FDRs for Rs.12.00 lakhs. Details of the website have also not been submitted. **Hence, Show Cause Notice be issued as to why recognition should not be refused. Reply should be submitted within one month.**

The applicant be advised to complete all the formalities necessary after issue of LOI on or before 3rd March, 2018, if the case is to be considered for Recognition from the academic session 2018-2019. Accordingly, Show Cause Notice was issued on 20.02.2018.

AND WHEREAS, the reply dt. 28.02.2018 of the Institution was placed before WRC in its 289th meeting held on March 1 & 3, 2018. The Committee decided that "...Show Cause Notice was issued to the institution on 20.02.2018. Reply submitted by the institution was examined in conjunction with File No.223284 and it is noticed that many of the faculty members are same in both the staff lists.

Secondly, though LOI is issued on 21.11.2017, the date of appointment of faculty members is shown is as prior to the issue of LOI. **Hence, Recognition is refused. FDRs if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to **PT. RAMLAL SHARMA COLLEGE OF EDUCATION, KHASRA NO. 101/4, VILLAGE: BUDHWADA, STREET/ROAD: HARDA BYPASS, TALUKA/ MANDAL + TOWN/CITY: HOSHANGABAD, DISTRICT: HOSHANGABAD-461001, MADHYA PRADESH** for the **B.A.B.Ed. 4 - Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
