REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, **IGNTU (INDIRA GANDHI NATIONAL TRIBAL UNIVERSITY), PLOT NO.: 148, 150, 213, STREET/ROAD: LALPUR VILL.: LALPUR, P.O.: LALPUR IGNTU CAPMPUS, TEH./TAL.: PUSH PRAJGARH, TOWN/CITY: AMARKANTAK, DIST.: ANUPPUR - 484887, MADHYA PRADESH (APP2591/M.Ed.)** had submitted the application on **29.05.2015** to the Western Regional Committee of the NCTE for grant of recognition/permission to **IGNTU (INDIRA GANDHI NATIONAL TRIBAL UNIVERSITY), PLOT NO.: 148, 150, 213, STREET/ROAD: LALPUR VILL.: LALPUR, P.O.: LALPUR IGNTU CAPMPUS, TEH./TAL.: PUSH PRAJGARH, TOWN/CITY: AMARKANTAK, DIST.: ANUPPUR - 484887, MADHYA PRADESH** for **M.Ed. 2 years course**.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on **15.07.2015** requesting to give their recommendation/ comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated **09.10.2015** has given the recommendation.

AND WHEREAS, in 237th meeting of the WRC held on December 21-22, 2015, it was decided **"...The IGNTU has applied for M.Ed. course. The applicant has applied for four other teacher education courses while normal education courses are already being run. This is a Central University to which land has been allotted by the State Government. Since all required documents are submitted, VT be constituted."**

AND WHEREAS, the Visiting Team visited the institution on 21.01.2016.

AND WHEREAS, the visiting team report alongwith other documents, were placed before WRC in its 241st meeting held on February 4-6, 2016. The Committee decided that **"...The VT has informed that the institution has good facilities. The CD was seen. The CD bears out observations of the VT. Hence, LOI under Clause 7(13) of NCTE Regulations, 2014 be issued for one unit of M.Ed.**

The applicant be advised to complete all the formalities necessary after issue of LOI before 3rd March, 2016, if the case is to be considered for Recognition from 2016-2017 session." Accordingly, LOI was issued on 13.02.2016.

AND WHEREAS, the reply dt. 22.06.2016 of LOI submitted by institution was placed before WRC in its 265th meeting held from December 27-29, 2016. The Committee decided that:-

"...The institution has submitted application for the B.A.B.Ed. and B.Sc.B.Ed. courses (Code-226002) and for the M.Ed. course APP2591. The staff profile has been submitted for all of these courses which are identical. As per NCTE Regulations, 2014, Appendices 13 and 5, the requirement is 1 Principal/HOD and 7 faculty members, for the B.A.B.Ed. course and a similar figure for the B.Sc.B.Ed. course. It means that 16 staff members are required for the B.A.B.Ed. and the B.Sc.B.Ed. courses. Further, for the M.Ed. course, the requirement is 2 Professors, 2 Associate Professors, and 6 Assistant Professors. The institution has in all 12 faculty members. This list is not sufficient for running the 3 courses. On scrutiny of their file for the B.Ed. course (APP2589), it is seen that the same list of faculty members also features here. Recognition for this course was issued on 27/09/2016. There is a serious problem with the staffing and it is surprising to see that the same list of staff is shown for four different courses. Hence, Show Cause Notice be issued on the above grounds. Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued on 03.01.2017.

AND WHEREAS, the reply dt. 31.01.2017 of the Institution was placed before WRC in its 276th meeting held on May 30-31, 2017. The Committee decided that **"...The institution has requested for more time to recruit the staff. Case be put up as soon as the list of staff is submitted."**

AND WHEREAS, the Clarification letter was issued on 06.06.2017.

AND WHEREAS, the matter of reply not received was placed before WRC in its 289th meeting held on March 1 & 3, 2018. The Committee decided that "...The University was asked to fulfill the staff requirement vide LOI dated 13.02.2016 followed by a Show Cause Notice dated 03.01.2017 and clarification letter dated 06.06.2017. No reply has been received till date. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to **IGNTU (INDIRA GANDHI NATIONAL TRIBAL UNIVERSITY), PLOT NO.: 148, 150, 213, STREET/ROAD: LALPUR, PENDRA ROAD, VILL.: LALPUR, P.O.: LALPUR, AMARKANTAK, TEH./TAL.: PUSHRAJGARH, TOWN/CITY: AMARKANTAK, DIST.: ANUPPUR- 484887, MADHYA PRADESH** for the **M.Ed. 2 - Years** programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
