The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

The institution shall fill the GIS information on the NCTE website within one month from the date of this order.



The institution shall maintain & update its web site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- a) Sanctioned programmers along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications and scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarters;
- d) Name of Students admitted during the current session along with qualification, percentage, of marks in the qualifying examination and in the entrance test, if any, date of admission, etc;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
