REFUSAL ORDER

WHEREAS in terms of section 14 of the NCTE Act, 1993, PT.D.D. PATHAK SHIKSHA PRASAR SAMITI, VILLAGE: CHHATARPUR, STREET/ROAD: WARD NO 23, NAZAR BAG, BEHIND MAHAL, TALUKA/MANDAL + TOWN/CITY: CHHATARPUR, DISTRICT: CHHATARPUR-471001, MADHYA PRADESH had submitted the application on 31.05.2016 to the Western Regional Committee of the NCTE for grant of recognition to PT.D.D. PATHAK MAHAVIDYALAYA, SURVEY NO. 649/5, 670/4, 649/4/2, VILLAGE: LAVKUSHNAGAR, STREET/ROAD: VIDHAYAK COLONY, MAHOBA ROAD, TALUKA/MANDAL + TOWN/CITY: LAVKUSHNAGAR, DISTRICT: CHHATARPUR-471515, MADHYA PRADESH for conducting the B.A.B.Ed. 4 Years integrated programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 17.06.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 264th meeting of the WRC held on December 14-15, 2016 it was decided as under:

"...The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately." $^{\prime\prime}$

AND WHEREAS, As per above decision, V.T. was constituted through online on 18.02.2017.

AND WHEREAS, the Institution vide letter dt. 04.03.2017 refused the inspection.

AND WHEREAS, the matter considered by WRC in its 283rd meeting held on November 14-15, 2017. The Committee decided that "....VT was constituted vide letter dated 18.02.2017 but the institution refused inspection due to some personal reasons.

Hence, VT will be constituted on submission of fee of Rs.1.50 lakhs within one month, failing which the Recognition will be refused. Show Cause Notice be issued to the institution."

AND WHEREAS, the Show Cause Notice was issued on 20.11.2017.

AND WHEREAS, the matter of reply not received was placed before WRC in its 288th meeting held on February 15-16, 2018. The Committee decided that "....Show Cause Notice was issued to the institution on 20.11.2017. The institution has not replied till date. **Hence, Recognition is refused."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to PT.D.D. PATHAK MAHAVIDYALAYA, SURVEY NO. 649/5, 670/4, 649/4/2, VILLAGE: LAVKUSHNAGAR, STREET/ROAD: VIDHAYAK COLONY, MAHOBA ROAD, TALUKA/MANDAL + TOWN/CITY: LAVKUSHNAGAR, DISTRICT: CHHATARPUR-471515, MADHYA PRADESH for the B.A.B.Ed. 4 Years integrated programme.
