REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, LATE SMT SAMPAT BAI JAIN APLSANKYAK KALYAN SAMITI, VILLAGE - MADHAVGANJ, STREET/ROAD - MAHAVEER DAL MILL, TALUKA/MANDAL - MADHAVGANJ, TOWN/CITY - AJAIGARH, DISTRICT - PANNA, PIN CODE - 488220, MADHYA PRADESH (Code No.APP201660106/9750) had submitted on 31.05.2016 the application to the Western Regional Committee of the NCTE for grant of recognition to, MJM COLLEGE, VILLAGE - BARETHIYA, STREET/ROAD - NAGOD ROAD, TALUKA/MANDAL - UNCHEHARA, TOWN/CITY - BARETHIYA, DISTRICT - SATANA, PIN CODE - 485441, MADHYA PRADESH for starting the D.El.Ed. Course

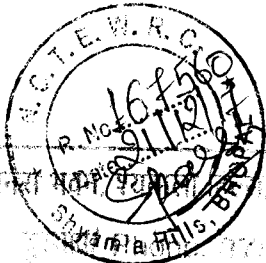
AND WHEREAS, the matter was placed before WRC in its 266th meeting held on January 10-12, 2017 and the Committee decided that "...An examination of the file shows that the proposed application is for a standalone institution which is not permitted under clause 2(b) and 3(a) of the NCTE Regulations, 2014. Hence, Show Cause Notice be issued to the institution on the above ground. Reply should be submitted within 30 days." Accordingly, Show Cause Notice was issued on 18.01.2017.

AND WHEREAS, reply received from the institution was placed in the 269th WRC meeting held on February 20-22, 2017 and the Committee observed that "...The institution has applied for the D.El.Ed. course with 2 units, the B.Ed. course and the B.Sc.B.Ed. course. The institution applications for the D.El.Ed. and B.Ed. courses cannot be considered because these 2 courses are open only for minority institutions for the session 2017-2018. The Society has not submitted the Minority Certificate for its MJM College. If the above two courses are not permitted then, its application for the B.A./B.Sc.B.Ed. cannot be considered as the college will become a standalone institution which is not permitted under clause 2(b) and 3(a) of the NCTE Regulations, 2014. Hence, Recognition is refused for all the three courses." Accordingly, Refusal order was issued on 27.02.2017.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Refusal order dated 27.02.2017 and the Council vide order dated 21.08.2017 remanded the case to WRC for granting last opportunity to the appellant to submit evidence in support of either a clear-cut minority status or a communication in support of 'deemed' to have been granted NOC status, which appellant should obtain by seeking information under the RTI Act. Appellant is to submit information within 2 months from the date of issue of appeal orders.

AND WHEREAS, the aforesaid appeal order was placed before WRC in its 281st meeting held on September 19-20, 2017 and the Committee decided that "...The WRC in its 269th meeting refused recognition to the institute D.El.Ed. (ID 9750), the B.Ed. course (ID 8734) and B.Sc.B.Ed. course (ID 10676). The D.El.Ed. course was refused because it has not submitted Minority certificate. The institute went in appeal. The Appellate Authority vide order dt. 21.08.2017 has given two months' time for submission of the minority certificate. The institute is required to submit the minority certificate by 21st October, 2017 to submit same failing which the WRC decision cited above will stand." Accordingly, letter was issued on 03.10.2017.




