REFUSAL ORDER

WHEREAS in terms of section 15 of the NCTE Act, 1993, **Smt. Archana Devi Sharma Shiksha Prasara Evam Samaj Kalyan Samiti, Village: Shivpuri, Street/Road: Chattri Road, Taluka/Mandal: + Town/City: Shivpuri, District: Shivpuri-473551, Madhya Pradesh** had submitted the application on **31.05.2016** to the Western Regional Committee of the NCTE for grant of recognition to **Swami Vivekanand College of Professional Studies, Plot/Khasra No. 793, 804, 806, 809, 815, Village: Kankar, Street/Road: A.B.Road, Post: Satanbada, Taluka/Mandal+Town/City: Shivpuri, District: Shivpuri-473638, Madhya Pradesh** for conducting the **B.A.B.Ed. 4 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 20.06.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 264th meeting of the WRC held on December 14-15, 2016 it was decided as under:

"...The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

AND WHEREAS, the Visiting Team visited the institution on 28.01.2017.

AND WHEREAS, the visiting team report alongwith other documents, were considered by WRC in its 269th meeting held on February 20-22, 2017. The Committee decided that *"...The VT visited the institution on 28/01/2017. The VTR was perused and the CD viewed. The CD shows a building with adequate instructional and infrastructural facilities. The VT has recommended the case. Hence, LOI be issued for 1 unit. The institution should clarify whether it is for B.A.B.Ed. course or the B.Sc.B.Ed. course."*

AND WHEREAS, the Letter of Intent was issued on 16.03.2017.

AND WHEREAS, the matter of reply not received was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that *"...LOI was issued on 16.03.2017. Till date no reply has been received. Show Cause Notice be issued."*

AND WHEREAS, the Show cause notice was issued on 18.08.2017.

AND WHEREAS, the matter of reply not received was placed before WRC in its 288th meeting held on February 15-16, 2018. The Committee decided that *"...Consequent to the issue of LOI, Show Cause Notice was issued to the institution on 18.08.2017. Till date no reply has been received. Hence, Recognition is refused."*

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to **Swami Vivekanand College of Professional Studies, Plot/Khasra No. 793, 804, 806, 809, 815, Village: Kankar, Street/Road: A.B.Road, Post: Satanbada, Taluka/Mandal +Town/City: Shivpuri, District: Shivpuri-473638, Madhya Pradesh** for the **B.A.B.Ed. 4 Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
