REFUSAL ORDER

WHEREAS, in terms of Section 14 (1) of the NCTE Act, 1993, **PREM MAHENDRA SHIKSHA EVAM SAMAJ KALYAN PARISHAD, VILLAGE: AAHUKHANA KALA, STREET/ROAD: URVAI GATE, TALUKA/MANDAL +TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474012, MADHYA PRADESH (APP201660185)** had submitted the application on **22.06.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to **RAJIV GANDHI VOCATIONAL EDUCATION & TRAINING COLLEGE, VILLAGE: AAHUKHANA KALA, STREET/ROAD: SHABD PRATAP ASHRAM ROAD URVAI GATE, TALUKA/MANDAL+TOWN/CITY: GWALIOR, DISTRICT: GWALIOR - 474012, MADHYA PRADESH** for **B.A.B.Ed. 4 years integrated course.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 11.07.2016, 16.09.2016 & 25.09.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 266th meeting of the WRC held on January 10-12, 2017 it was decided as under:

"The WRO should process all the files and send VT to all institutions which fulfill all the requirements as per Regulations. Show Cause Notice can be issued to all institution which have not submitted a valid up to date CLU with payment receipts. The rest of the applications should be put up to the WRC for disposal."

AND WHEREAS, the Show Cause Notice was issued on 17.03.2017 through online.

AND WHEREAS, the reply dt.06.04.2017 of the Institution was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that *"...Show Cause Notice issued on 17.03.2017 regarding latest premium receipt of CLU which the institute has not submitted. Further since all the courses are being held in Khas No. 355 to 361, the institute should specify what the exact address is so that the correspondence can be sent to the address. There should not be multiple addresses. VT be constituted as soon as the latest CLU premium receipt is submitted. The institute should also submit Building Completion Certificate from Govt. Engineer to the VT/office."*

AND WHEREAS, the inspection of the institution was conducted on 14.10.2017. The matter was placed before WRC in its 282nd meeting held on October 24-26, 2017. The Committee decided that *"...VT visited the institution on 14.10.2017. VTR was perused and the CD was seen. The CD is unsatisfactory as it failed to show the facade/elevation of the building, main entrance to the building and the videography is disjointed. Hence, it is not possible to assess the institution on the basis of these video clips. The existence of the D.El.Ed., B.Ed. and M.Ed. courses are not seen. The laboratories are not operational and shows an accumulation of equipment. The other infrastructure like classrooms, multipurpose hall etc. seems to be unused."*

WRC is unsatisfied with the CD and decided that fresh VT is required to be constituted. This VT should give a comprehensive report of all the courses running and proposed.

Hence, fresh VT be constituted. The VT should ensure that continuous videography be done and the unedited CD should be obtained from the videographer and sent to WRC."

AND WHEREAS, the institution email dt. 21.11.2017 was placed before WRC in its 285th meeting held on December 19-21, 2017. The Committee decided that "...VT was constituted on 01.11.2017 but the institution vide email dated 21.11.2017 has informed that the management has decided not to apply for the above mentioned courses. **Hence, Recognition is refused.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to **RAJIV GANDHI VOCATIONAL EDUCATION & TRAINING COLLEGE, VILLAGE: AAHUKHANA KALA, STREET/ROAD: SHABD PRATAP ASHRAM ROAD URVAI GATE, TALUKA/MANDAL+TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474012, MADHYA PRADESH** for the **B.A.B.Ed. 4 - Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
