REFUSAL ORDER

WHEREAS in terms of section 14 of the NCTE Act, 1993, **SHRI SHIYAWAR SHIKSHA SAMITI, VILLAGE: KEOWARI KALA, STREET/ROAD: MAIN ROAD, TALUKA/MANDAL: REHLI, TOWN/CITY: SAGAR, DISTRICT: SAGAR-470235, MADHYA PRADESH** had submitted the application on **30.06.2016** to the Western Regional Committee of the NCTE for grant of recognition to **DIGNITY COLLEGE, SURVEY NO. 104/2, VILLAGE: KEOWARI KESLI, STREET/ROAD: MAIN ROAD, TALUKA/MANDAL: KESLI, TOWN/CITY: SAGAR, DISTRICT: SAGAR-470235, MADHYA PRADESH** for conducting the **B.Sc.B.Ed. 4 Years** integrated programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 16.08.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 264th meeting of the WRC held on December 14-15, 2016 it was decided as under:

"...The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

AND WHEREAS, As per above decision, V.T. was constituted through online on 10.02.2017.


AND WHEREAS, the VT member vide email dt. 24.06.2017 has stated that "...NCTE appoint me a VT MEMBER in Dignity College, Keowari Kesli, Sagar District, M.P. for the inspection of B.A.B.Ed./B.Sc.B.Ed. in the time frame 20/02/2017 to 12/03/2017. I contacted so many times of the college registered mobile number but college concern person was not responding proper regarding inspection. So I request you to take necessary action regarding Inspection of institution."

AND WHEREAS, the matter considered by WRC in its 283rd meeting held on November 14-15, 2017. The Committee decided that "...VT was constituted on 10.02.2017. However, the visit could not take place because of lack of response from the institution.

For reconstituting the VT, the institution is required to deposit fee of Rs.1.50 lakhs. Thereafter VT can be constituted. Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn." Accordingly letter was issued to the institution on 05.01.2018 for submission of Rs. 1.50 lakh as inspection fee.

AND WHEREAS, the matter of reply not received was placed before WRC in its 288th meeting held on February 15-16, 2018. The Committee decided that "...Show Cause Notice was issued to the institution on 05.01.2018. The institution has not replied till date. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to **DIGNITY COLLEGE, SURVEY NO. 104/2, VILLAGE: KEOWARI KESLI, STREET/ROAD: MAIN ROAD, TALUKA/MANDAL: KESLI, TOWN/CITY: SAGAR, DISTRICT: SAGAR-470235, MADHYA PRADESH** for the **B.Sc.B.Ed. 4 Years** integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
