**REFUSAL ORDER**

WHEREAS in terms of section 14 of the NCTE Act, 1993, **NAV SRAJAN SHIKSHA SEVA SASTHAN, VILLAGE: BHENSODAMANDI, STREET/ROAD NO.: 11, TALUKA/MANDAL: BHANPURA, TOWN/CITY: BHENSODAMANDI, DISTRICT: MANDSAUR-458778, MADHYA PRADESH** had submitted the application on **30.06.2016** to the Western Regional Committee of the NCTE for grant of recognition to **KRISHNA COLLEGE OF EDUCATION, VILLAGE: BHENSODAMANDI, STREET/ROAD NO.: 11, NEAR CENTRAL BANK, TALUKA/MANDAL: BHANPURA, TOWN/CITY: BHENSODAMANDI, DISTRICT: MANDSAUR-458778, MADHYA PRADESH** for conducting the **B.A.B.Ed. 4 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 01.08.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 269<sup>th</sup> meeting held on February 20-22, 2017 and the Committee decided that "...The institution has applied for the B.A.B.Ed. and B.Sc.B.Ed. courses. The NCTE Hqrs. vide letter dt. 03/03/2016 has clarified that B.A.B.Ed./ B.Sc.B.Ed. (integrated Programme) is one programme. The programme can't be segregated into two programmes with different nomenclature. Since, the institution is not running any other programme/course, it becomes a standalone institution which is not permitted under clause 2(b) and 3(a) of the NCTE Regulations, 2014. **Hence, Show Cause Notice be issue on the above grounds. Reply should be submitted within 30 days.**"

AND WHEREAS, the Show Cause Notice was issued on 06.03.2017 through online.

AND WHEREAS, the reply dt. 20.03.2017 of the Institution was placed before WRC in its 279<sup>th</sup> meeting held on August 10-11, 2017. The Committee decided that "...The institute had applied separately for the B.A B.Ed and B.Sc B.Ed courses. Show Cause Notice was issued to the institution on 06.03.2017 on the ground that the B.A-B.Ed and the B.Sc B.Ed (Integrated programme) is one programme and not two. Therefore, the institute is standalone. The institute has not replied satisfactorily to the Show Cause Notice. **Hence, recognition is refused. FDRs, if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to **KRISHNA COLLEGE OF EDUCATION, VILLAGE: BHENSODAMANDI, STREET/ROAD NO.: 11, NEAR CENTRAL BANK, TALUKA/MANDAL: BHANPURA, TOWN/CITY: BHENSODAMANDI, DISTRICT: MANDSAUR-458778, MADHYA PRADESH** for the **B.A.B.Ed. 4-Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website [www.ncte-india.org](http://www.ncte-india.org).
