**REFUSAL ORDER**

WHEREAS in terms of section 14 of the NCTE Act, 1993, **Late Shree Shivnarayan Gurjar Shakshani Evam Janseva Samiti, Village: Bhorakhedi, Street/Road: Hamirpur Patan Road, Taluka/Mandal: Bamori, Town/City: Guna, District: Guna - 473001, Madhya Pradesh** had submitted the application on **30.06.2016** to the Western Regional Committee of the NCTE for grant of recognition to **S.N. Memorial Educational College, Survey No. 56/2, Village: Bhorakhedi, Street/Road: Hameerpur Road, Taluka/Mandal: Bamori, Town/City: Bhorakhedi, District: Guna-473001, Madhya Pradesh** for conducting the **B.A.B.Ed. 4 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 16.08.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 264<sup>th</sup> meeting of the WRC held on December 14-15, 2016 it was decided as under:

"...The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

AND WHEREAS, As per above decision, V.T. was constituted through online on 15.02.2017.


AND WHEREAS, the Institution vide letter dt. 08.03.2017 refused for V.T.

AND WHEREAS, the matter was placed before WRC in its 285<sup>th</sup> meeting held on December 19-21, 2017. The Committee decided that "...VT was constituted on 15.02.2017. However, the institution vide letter dated 08.03.2017 informed that the institution is not ready for VT in June 2017 due to illness of Chairman.

*For reconstituting the VT, the institution is required to deposit fee of Rs.1.50 lakhs. Thereafter VT can be constituted. Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."* Accordingly, letter was issued to the institution on 05.01.2018 for submission of Rs. 1.50 lakh as inspection fee.

AND WHEREAS, the matter of reply not received was placed before WRC in its 288<sup>th</sup> meeting held on February 15-16, 2018. The Committee decided that "...Show Cause Notice was issued to the institution on 05.01.2018. The institution has not replied till date. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to **S.N. Memorial Educational College, Survey No. 56/2, Village: Bhorakhedi, Street/Road: Hameerpur Road, Taluka/Mandal: Bamori, Town/City: Bhorakhedi, District: Guna-473001, Madhya Pradesh** for the **B.A.B.Ed. 4 Years integrated programme.**
