REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, GOVERNMENT UNIVERSITY, PLOT NO: HOUSE NO- 02, STREET: NO: 123, VILLAGE- BHOJ UNIVERSITY CAMPUS, POST OFFICE: KOLAR ROAD, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462042, MADHYA PRADESH had submitted the online application on 16.04.2015 to the Western Regional Committee of the NCTE for grant of recognition to ATAL BIHARI VAJPAYEE HINDI VISHVAVIDYALAYA, PLOT NO: HOUSE NO- 02, BLOCK NO: 04, STREET NO: 123, VILLAGE- BHOJ UNIVERSITY CAMPUS, POST OFFICE: KOLAR ROAD, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462016, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 241st Meeting held on February 4-6, 2016, the committee observed that:- "...In this case, the application was made online on 16/04/2015, whereas the hard copy has been received on 08/06/2015, which is in opposition to clause 7(2)(b) of the NCTE Regulations, 2014.

In the light of letter No. 49-20/2014/NCTE/N&S/20328 dt. 14/01/2016 received from the NCTE Hqrs., the delay in submission of the hard copy is condoned.

The case to be processed further."

AND WHEREAS, the matter was placed before the WRC in its 251st Meeting held on April 30-May 2, 2016, the committee observed that:- "...The institution has made two applications for the B.Ed. course. One APP2671 and the other APP2541.

The University may clarify as to why two separate applications are required for the same course."

AND WHEREAS, the Clarification letter was issued to the institution on 06.05.2016 and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 266th Meeting held on January 10-12, 2017 and the Committee observed that "...Clarification letter/Show Cause Notice dt. 06/05/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to ATAL BIHARI VAJPAYEE HINDI VISHVAVIDYALAYA, PLOT NO: HOUSE NO- 02, BLOCK NO: 04, STREET NO: 123, VILLAGE- BHOJ UNIVERSITY CAMPUS, POST OFFICE: KOLAR ROAD, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462016, MADHYA PRADESH for B.ED. Course.
