Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Babubhai Kanakia Foundation, Plot No. - 237 N, Street/Road-Indralok Phaze 6, Village - Navghar, Post Office Bhayander, Tehsil/Taluka - Thane, City-Mira Bhayander, District-Thane, Maharashtra - 401105 had submitted the application to WRC online on 09.05.2015 for grant of recognition to Ramaben Babubhai Kanakia, Plot No. - (O)237(N), (O)241(N), (O)242(N), Street No. - Phaze 6, Village - Navghar, Post Office - Bhayander, Tehsil/Taluka - Thane, City - Mira Bhayander, District-Thane, Maharashtra - 401105 for B.Ed. course.

And whereas, the proposal was examined and copy of the application was sent to the State Govt. on 10.07.2015 for seeking their comments/recommendation. The State Govt. sent its recommendation vide letter dated-09.10.2015.

And whereas, the matter was placed before the WRC in its 232<sup>nd</sup> meeting held on September 16-17, 2015. The Committee decided that the application be summarily rejected and fees be forfeited.

And whereas, the Committee in its 234<sup>th</sup> meeting held on November 03-05, 2015 decided that:-

Regarding applications received for the academic session 2016-2017 without NOC of the affiliating body, the WRO placed before the WRC the minutes of the meeting of RDs and NCTE Officers held on 11<sup>th</sup> October 2015. In the meeting it was decided that "Show Cause Notice" be issued in case of non-submission of NOC on or before 15<sup>th</sup> July, 2015". Acting on this directive from NCTE Hqrs, the WRC decided to issue a Show Cause Notice before rejection in all such cases.

And whereas, the matter was placed before the WRC in its 237<sup>th</sup> meeting held on November 23-24, 2015. The Committee decided to issue Show Cause Notice to the institution. Accordingly, Show Cause Notice was issued on 04.01.2016. The institution did not submit reply to the letter.

And whereas, the matter was placed before WRC in its 242<sup>nd</sup> meeting held on February 11-13, 2016, and the Committee decided as follows:-

The case relates to the B.Ed. course. A Show Cause Notice was issued to the institution on 04/01/2016 on the following grounds:-

- (i) Two land documents have been submitted, one document shows a private lease which is not accepted at all, the other document is in Marathi language. Hence, notarized translated copy of the second land document be submitted. It cannot be seen whether the land is acceptable as per NCTE Regulations, 2014;
- (ii) None of the other documents viz., approved building plan, CLU, building completion certificate, non-encumbrance certificate has been submitted. Notarized copy is required to be submitted.
- (iii) NOC from the affiliating body not submitted;
- (iv) At present only this case APP2560 is under consideration. Neither the applicant is running any other education/teacher education course nor is any other application pending in WRC, so this case would be stand alone institution; and
- (v) State Government has not recommended the case.

The institute has not replied to the Show Cause Notice.

Hence, Recognition is refused.

Now, therefore, in exercise of the powers vested under section 14(3)(b) of NCTE Act, 1993, the Western Regional Committee hereby refuses recognition to Ramaben Babubhai Kanakia, Plot No. - (O)237(N), (O)241(N), (O)242(N), Street No. - Phaze 6, Village - Navghar, Post Office - Bhayander, Tehsil/Taluka - Thane, City - Mira Bhayander, District-Thane, Maharashtra - 401105 for conducting the B.Ed. Programme.

Further, if the institution is not satisfied by the Order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this Order.
