REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, CREZ EDUCATION WELFARE SOCIETY, PLOT NO: 795, STREET: TIGHRA ROAD, VILLAGE: GWALIOR, POST OFFICE: MOTIJHEEL, TEHSIL: GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH had submitted the online application on 27.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to RAMESH TEACHER TRAINING B.ED. COLLEGE, PLOT NO: 795, STREET: TIGHRA ROAD, VILLAGE: BARA, POST OFFICE: MOTIJHEEL, TEHSIL: GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 17.07.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the negative recommendation.

AND WHEREAS, the matter was placed before the WRC in its 247<sup>th</sup> meeting held on April 4-6, 2016, the committee observed that: - "...The institution is running the D.Ed. course with one unit (222531).

An examination of the file shows that the institution has not submitted Society registration and Bye-laws. It has also not submitted notarized copies of Building Completion Certificate, CLU and Non-Encumbrance Certificate. Further, it is seen that another institution Sarla Devi Shiksha Mahavidyalaya (APP2652) is also running by the same Society in the same plot.

Hence, Show Cause Notice be issued on the above grounds."

AND WHEREAS, the Show Cause Notice was issued to the institution on 07.04.2016 and the reply of Show Cause Notice was received on 21.04.2016 & 23.05.2016.

AND WHEREAS, the reply was placed before the WRC in its 257<sup>th</sup> Meeting held on August 2-4, 2016, the committee observed that: - "...In response to the Show Cause Notice dt. 07/04/2016, the applicant has submitted all the documents which are in order.

Hence, VT is constituted.

It is seen that the land documents of this applicant are the same as the documents in APP2652 of Sarla Devi Shiksha Mahavidyalaya, Vilage-Bara Gwalior. Apart from the usual inspection that a VT has to carry out, the VT must also ascertain whether they are two different buildings for two different institutions."

AND WHEREAS, institution vide letter dated 03.08.2016 received in WRO on 08.08.2016 has requested to close the application for B.Ed. Course.

AND WHEREAS, the matter was placed before the WRC in its 258<sup>th</sup> Meeting held on August 22-24, 2016 and the committee observed that "...institution vide its letter dt. 03/08/2016 has applied for withdrawing its application for B.Ed. course. However, a resolution of the Society has not been submitted. A Resolution be obtained."

AND WHEREAS, the Clarification letter was issued to the institution on 31.08.2016 and and the institution has not submitted the reply till date.

**AND WHEREAS**, the matter was placed before the WRC in its 266<sup>th</sup> Meeting held on January 10-12, 2016 and the Committee observed that "...Clarification letter/Show Cause Notice dt. 31/08/2016 was issued to the institution and reply has not submitted by the institution till date.

**Hence, Recognition is refused."**

**NOW, THEREFORE**, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **RAMESH TEACHER TRAINING B.ED. COLLEGE, PLOT NO: 795, STREET: TIGHRA ROAD, VILLAGE: BARA, POST- OFFICE: MOTIJHEEL, TEHSIL: GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH** for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, I, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website [www.ncte-india.org](http://www.ncte-india.org).


