**REFUSAL ORDER**

**WHEREAS**, in terms of Section 14 of the NCTE Act, 1993, **VAISHNAV MATA SHIKSHA SAMITI, PLOT NO: 1229/2, STREET: PANNA MAIN ROAD, VILLAGE: PANNA, POST OFFICE: PANNA, TEHSIL: PANNA, CITY: PANNA, DISTRICT: PANNA- 488001, MADHYA PRADESH** had submitted the application online on **29.05.2015** to the Western Regional Committee of the NCTE for grant of recognition **MATA SARASWATI SHIKSHA MAHAVIDHYALAYA, PLOT/KHASRA NO: 1229/2, VILLAGE: PANNA, POST OFFICE: PANNA, TEHSIL: PANNA, CITY: PANNA, DISTRICT: PANNA- 488001, MADHYA PRADESH** for starting the **B.ED.** Course.

**AND WHEREAS**, the application of the institution was processed.

**AND WHEREAS**, SCN was issued to the institution on **10.02.2016** and the reply of SCN was received on **15.03.2016**.

**AND WHEREAS**, the matter was placed before WRC in its **254<sup>th</sup> Meeting held on June 7-9, 2016** and the Committee decided that "...Show Cause Notice was issued on 10/02/2016 and the reply was received on 15/03/2016. The institution has still not submitted originally certified copy of the land documents, approved building plan and Non-Encumbrance Certificate not submitted. The institution has not given any clarification regarding the fact that the institution is running any other course to make it a composite one which is required under clause 2(b) of the NCTE Regulations, 2014. The institution has also not given any clarification that they have submitted two applications for the B.Ed. course (APP2741) and (APP2742) which have the same details of land, building etc.

**Hence, Recognition for B.Ed. course is refused."**

**NOW, THEREFORE**, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **MATA SARASWATI SHIKSHA MAHAVIDHYALAYA, PLOT/KHASRA NO: 1229/2, VILLAGE: PANNA, POST OFFICE: PANNA, TEHSIL: PANNA, CITY: PANNA, DISTRICT: PANNA- 488001, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online Mode using website [www.ncte-india.org](http://www.ncte-india.org).
