REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **INDUS GLOBAL EDUCATIONAL AND WELFARE SOCIETY, PLOT NO- 255, 256/1, STREET- INDORE-DEWAS BYPASS ROAD, VILLAGE- NIPANIA, POST OFFICE- INDORE, TEHSIL- INDORE, CITY- INDORE, DISTRICT: INDORE- 452016, MADHYA PRADESH** had submitted the online application on 30.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to **MALWA INSTITUTE OF TEACHERS EDUCATION, PLOT/ KHASARA NO- 255, 256/1, PLOT NO- 17, VILLAGE- NIPANIA, POST OFFICE- INDORE, TEHSIL- INDORE, CITY- INDORE, DISTRICT: INDORE- 452016, MADHYA PRADESH** for starting the **B.ED. Course**.

**AND WHEREAS**, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 13.08.2015 requesting to give their recommendation/comments.

**AND WHEREAS**, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 gave its recommendation.

**AND WHEREAS**, the matter was placed before the WRC in its 235<sup>th</sup> Meeting held on November 23-24, 2015 and the Committee observed that "...The College applied online on 30.05.2015. However, the hard copy was received on 09.07.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

**Hence, the application is summarily rejected and application fee paid be forfeited."**

**AND WHEREAS**, the Rejection Letter was issued on **03.12.2015** and Appeal order dated **02.06.2016** was received on **14.06.2016** remanding the case to WRC.

**AND WHEREAS**, the matter was placed before the WRC in its 259<sup>th</sup> Meeting held on September 21-23, 2016 and the Committee observed that "... This is a case of Appeal. The Appellate Authority vide order dt. 02/06/2016 has remanded the case to process the application further.

An examination of the application shows that Society has not submitted its By-laws. It has also not submitted originally certified copy of the land documents, notarized copy of Building Plan, notarized copy of Building Completion Certificate approved by the competent authority, and notarized copy of CLU. It has also not submitted notarized copy of Non-Encumbrance Certificate approved by the competent authority.

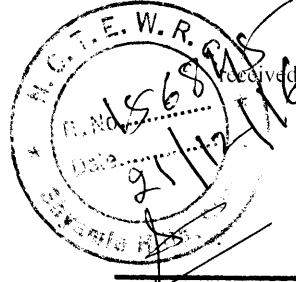
Further, it is seen that this institution is a stand alone institution which is not permitted under clause 2(b) of the NCTE Regulations, 2014. Also it is noticed that the State Govt. has issued a negative recommendation.

Show Cause Notice be issued on the above grounds.

Reply should be received in WRO within 21 days."

**AND WHEREAS**, The Show Cause Notice was issued to the institution on **28.09.2016** and reply was received on **17.10.2016**.

**AND WHEREAS**, the matter was placed before the WRC in its 263<sup>rd</sup> Meeting held on November 25-27, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on 28/09/2016 and reply received on 17/10/2016.

An examination of the documents show that while the MBA course is run by "Malwa Institute of Technology", the B.Ed. course is proposed to be run by "Malwa Institute Of Teachers Education".

Therefore, the application does not satisfy Clause 2(b) of the NCTE Regulations, 2014 regarding the composite nature of the institution.

**Hence, Recognition is refused."**

**NOW, THEREFORE**, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **MALWA INSTITUTE OF TEACHERS EDUCATION, PLOT/ KHASARA NO- 255, 256/1, PLOT NO- 17, VILLAGE- NIPANIA, POST OFFICE- INDORE, TEHSIL- INDORE, CITY- INDORE, DISTRICT: INDORE- 452016, MADHYA PRADESH** for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website [www.ncte-india.org](http://www.ncte-india.org).


