REFUSAL ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, **NALANDA EDUCATION SOCIETY SATNA, PLOT NO.396, STREET/ROAD - SANGRAM COLONY, VILLAGE/TOWN/CITY/POST OFFICE - SATNA, TEHSIL/TALUKA - RAGHURAJ NAGAR, DISTRICT - SATNA, PIN CODE - 485001, MADHYA PRADESH (WRCAPP2864/222)** had submitted the application on 30.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to **NALANDA COLLEGE OF EDUCATION, PLOT/KHASRA NO.134/1, 134/2, 135/2, STREET NO. JAIL ROAD, VILLAGE - KRIPALPUR, POST OFFICE - SATNA, TEHSIL/TALUKA - RAGHURAJ NAGAR, TOWN/CITY/DISRICT - SATNA, PIN CODE - 485001, MADHYA PRADESH** for D.El.Ed. Course of 2 year duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 29.10.2015, 17.12.2015 & 08.01.2016 requesting to give their recommendation/comments.

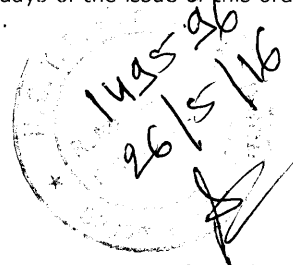
AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 19.01.2016 has given their recommendation.

AND WHEREAS, WRC in its 241st meeting of WRC held on February 4-6, 2016 decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be. Accordingly, Show Cause Notice was issued on 09.02.2016.

AND WHEREAS, reply received from the institution was placed in the 249th WRC meeting held on April 21-23, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on 09/02/2016 and reply was received on 09/03/2016 on various points. The institution has not satisfactorily replied to the points of the Show Cause Notice. **Hence, Recognition is refused.**"

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3)(b) of the NCTE Act, hereby refuses recognition to **NALANDA COLLEGE OF EDUCATION, PLOT/KHASRA NO.134/1, 134/2, 135/2, STREET NO. JAIL ROAD, VILLAGE - KRIPALPUR, POST OFFICE - SATNA, TEHSIL/TALUKA - RAGHURAJ NAGAR, TOWN/CITY/DISRICT - SATNA, PIN CODE - 485001, MADHYA PRADESH** for the D.El.Ed. Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
