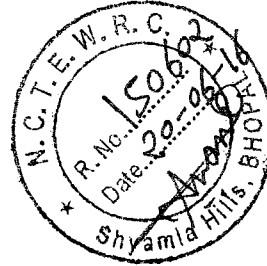
Hence, Recognition is refused."
