REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, R. PRAKASH SHIKSHA SAMITI, PLOT NO- 330, STREET- BARELA ROAD, CITY- KOSHAMGHAT, POST OFFICE- BARELA, TEHSIL- JABALPUR, CITY- JABALPUR, DISTRICT- JABALPUR- 483001, MADHYA PRADESH had submitted the online application on 04.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to VEDANTA BED COLLEGE, PLOT NO- 48, STREET: NB- 551, VILLAGE- KOSHAMGHAT, POST OFFICE- BARELA, TEHSIL- JABALPUR, CITY- JABALPUR, DISTRICT: JABALPUR- 483001, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 18.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before WRC in its 235<sup>th</sup> Meeting held on November 23-24, 2015 and the Committee decided that "...The College applied online on 04.06.2015. However, the hard copy was received on 06.07.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

Hence, the application is summarily rejected and application fee paid be forfeited."

AND WHEREAS, the Rejection Letter issued on 01.12.2015 and the Appeal order dated 18.04.2016 was received on 23.04.2016 & 26.04.2016 remanding the case to WRC.

AND WHEREAS, the matter was placed before WRC in its 253<sup>rd</sup> Meeting held on May 24-26, 2016 and the Committee decided that "...This is a case of Appeal. An examination of the file shows that the institution has not submitted the following:-

- Notarized copies of Society Registration and Bye-Laws, building plan, Building Completion Certificate, CLU, and Non-Encumbrance Certificate.
- It is also seen that the institution is a standalone one not conducting any other course which is not permitted as per clause 2(b) of the NCTE Regulations, 2014.

Hence, Show Cause Notice be issued on the above grounds. "

AND WHEREAS, Show Cause Notice was issued to the institution on 31.05.2016 and the reply of SCN was not received.

AND WHEREAS, the matter was placed before WRC in its 262<sup>nd</sup> Meeting held on November 10-11, 2016 and the Committee decided that "...Show Cause Notice was issued to the institution on 31/05/2016 on the grounds of non-submission of notarized copies of Society Registration and Bye-Laws, building plan, Building Completion Certificate, CLU, and Non-Encumbrance Certificate and the institution being a standalone one.

The institution has not replied till date.

Hence, Recognition is refused."


