**REFUSAL ORDER**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, RAJDHANI SHIKSHA SAMITI, PLOT NO- 5, STREET- BY PASS ROAD, CITY- BHOPAL, POST OFFICE- KAROND, TEHSIL- HUZUR, DISTRICT: BHOPAL- 462038, MADHYA PRADESH had submitted the online application on 28.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to NALANDA COLLEGE OF EDUCATION, KHASRA NO- 428/2/1/6 KHA, 428/2/1/6/6GA, 42, PLOT NO- 5, STREET- BY PASS, VILLAGE- BADBAI JOAD, POST OFFICE- KAROND, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT- BHOPAL- 462038, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the negative recommendation.

AND WHEREAS, the application of the institution was processed.

AND WHEREAS, Show Cause Notice was issued to the institution on 16.02.2016 on the following points:-

1. Name and Address of the institution not mention in NOC of the University/Affiliating body.
2. Address mentioned in Society Registration Certificate & Bye-Laws does not match with Online Application Form.
3. Photocopy of Land Documents Submitted but Certified copy not submitted. And name of the Institution does not match with Online Application Form.
4. Photocopy Building Plan submitted but Blue-Print/Notarized copy not submitted and Society Name, Address & Khasra No. also not mention.
5. Notarized copy of Building Completion Certificate not submitted.
6. Photocopy of CLU submitted but notarized copy not submitted and name of the Institution, does not match with Online Application Form.
7. Notarized copy of Non-Encumbrance Certificate not submitted.
8. FDRs not submitted as per NCTE norms.
9. In Online Application Form & as per office record, institution has not applied for /nor conducting any other Teacher Education Course. Hence, institution is not fulfilling Clause 2(b) of NCTE Regulations, 2014.

AND WHEREAS, the reply was not submitted by the institution.

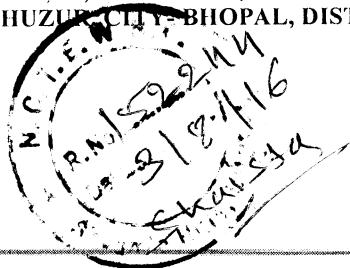
AND WHEREAS, the matter was placed before WRC in its 256<sup>th</sup> Meeting held on July 19-21, 2016 and the Committee decided that "... Show Cause Notice dt. 16/02/2016 was issued to the institution on the grounds of non-submission of certified land documents and originally notarized copy of CLU, Building Completion Certificate and Non-Encumbrance Certificate and being a standalone institution.

The Show Cause Notice has been returned as undelivered, even though the address is the same as the address given by the applicant in the application.

**Hence, Recognition is refused."**

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to NALANDA COLLEGE OF EDUCATION, KHASRA NO- 428/2/1/6 KHA, 428/2/1/6/6GA, 42, PLOT NO- 5, STREET- BY PASS, VILLAGE- BADBAI JOAD, POST OFFICE- KAROND, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT- BHOPAL- 462038, MADHYA PRADESH for B.ED. Course.
