**REFUSAL ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act **YASHI MEMORIAL SAMITI, PLOT NO.21, STREET/ROAD - CHITRA NAGAR CHATTRI ROAD, VILLAGE/TOWN/ CITY/POST OFFICE/TEHSIL/CITY/DISTRICT - SHIVPURI, PIN CODE - 473551, MADHYA PRADESH (WRCAPP3084/222)** had submitted the application on 28.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to **YASHI MEMORIAL COLLEGE, PLOT/KHASARA NO.10, VILLAGE/POST OFFICE - RAW SARJANGIR, TEHSIL/TALUKA - NAI SARAJ, TOWN/CITY - RAW SARJANGIR, DISTRICT - ASHOKNAGAR, PIN CODE - 473332, MADHYA PRADESH** for D.El.Ed. Course of 2 year duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 07.08.2015, 27.10.2015 and 09.12.2015 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, WRC in its 241<sup>st</sup> meeting of WRC held on February 4-6, 2016 decided that WRO should process the case and constitute VI/issue Show Cause Notice, as the case may be. Accordingly, Show Cause Notice was issued on 09.02.2016

AND WHEREAS, reply not submitted by the institution. The matter was placed in the 253<sup>rd</sup> WRC meeting held on May 24-26, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on 20/02/2016. Since the letter returned undelivered the same was uploaded on the website on 04/03/2016 and reply has not been received. **Hence, Recognition is refused.**"

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3)(b) of the NCTE Act, hereby refuses recognition to **YASHI MEMORIAL COLLEGE, PLOT/KHASARA NO.10, VILLAGE/POST OFFICE - RAW SARJANGIR, TEHSIL/TALUKA - NAI SARAJ, TOWN/CITY - RAW SARJANGIR, DISTRICT - ASHOKNAGAR, PIN CODE -473332, MADHYA PRADESH for the D.El.Ed. Course.**

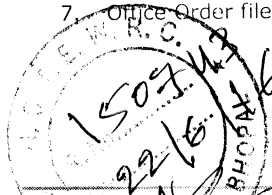
