REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SHATABDIKA MAHILA KALYAN SAMITI, PLOT NO- 414, STREET- ADITYA PURAM, VILLAGE- JADERUA, POST OFFICE- PINTO PARK, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474020, MADHYA PRADESH had submitted the online application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to SAISAGAR COLLEGE OF EDUCATION, PLOT/KHASARA NO- 414, 412/2, STREET-ADITYA PURAM, VILLAGE- JADERUA, POST OFFICE- PINTO PARK, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474020, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 11.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show Cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

- Society Registration Certificate & Bye- Laws not submitted.
- Address of the institution not mentioned in NOC of University/affiliating body.
- Khara No. 412/2 not mentioned in the affidavit.
- Photocopy of Building Plan submitted but Blue Print/notarized copy not submitted.
- Notarized copy of Building Completion Certificate not submitted.
- Notarized copy of CLU not submitted.
- FDRs not submitted, as per NCTE Regulations, 2014.
- In online application form, Applied/Existing course not mentioned but as per our record, the institution is applied for D.P.S.E. Course- (APP3198).
- Proof of running the BA, BBA, PGDCA Courses not submitted.

AND WHEREAS, the Show Cause Notice was issued to the institution on 17.02.2016 and the reply of Show Cause Notice was received on 20.04.2016.

AND WHEREAS, the reply was placed before the WRC in its 256th Meeting held on July 19-21, 2016. the committee observed that:- "...The documents submitted by the applicant in response to the Show Cause Notice dt. 17/02/2016 are in order, except that the permission from the Deputy Director, Town & Country Planning is only for Primary School and not for College building. As per the submitted Building Completion Certificate, the built up area is 3310 sq. mtrs only.

The documents submitted for the DPSE course (APP3198) were seen. In this file, an order of the SDO, Gwalior dt. 14/03/2005 was submitted. As per this order, the diverted land is 22,500 sq. ft. which is approximately 2000 sq. mtrs. only. Hence, the quantum of diverted land is less than the required 3000 sq. mtrs.

Clarification be obtained on the above grounds."

AND WHEREAS, the matter was placed before the WRC in its 266th Meeting held on January 10-12, 2017 and the Committee observed that "...Clarification letter/Show Cause Notice dt. 26/07/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **SAISAGAR COLLEGE OF EDUCATION, PLOT/KHASARA NO- 414, 412/2, STREET-ADITYA PURAM, VILLAGE- JADERUA, POST OFFICE- PINTO PARK, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR-474020, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
