REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, S.B. ALPSANKHYAK MULTIPURPOSE HUMAN DEVELOPMENT EDUCATION AND SOCIAL WELFARE SOCIETY, STREET- MAU DARWAZA, NEAR CITY POST OFFICE, POST OFFICE- CHHATARPUR, TEHSIL- CHHATARPUR, CITY- CHHATARPUR, DISTRICT: CHHATARPUR- 471001, MADHYA PRADESH had submitted the online application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to S.B. COLLEGE CHHATARPUR, PLOT NO- 88/2, 87/2, STREET- NOWGONG ROAD, VILLAGE- MUBASI, POST OFFICE- DHAMORA, TEHSIL- CHHATARPUR, CITY- CHHATARPUR, DISTRICT: CHHATARPUR- 471001, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the negative recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

“The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest...”

AND WHEREAS, Show Cause Notice was issued to the institution on 16.02.2016 on the following points:-


1. Registration no. 197/011 dated- 26.04.2011 in the name of S.B. MULTIPURPOSE HUMAN DEVELOPMENT EDUCATION AND SOCIAL WELFARE SOCIETY, Chhatarpur, M.P.
2. Bye- Laws in the name of S.B.ALPSANKHAYAK MULTIPURPOSE HUMAN DEVELOPMENT EDUCATION AND SOCIAL WELFARE SOCIETY, Chhatarpur, M.P.

6. Land documents in the name of Secretary, S.B. MULTIPURPOSE HUMAN DEVELOPMENT EDUCATION AND SOCIAL WELFARE SOCIETY, Chhatarpur, M.P.
7. Blue Print/Notarized copy of Building Plan issued by competent authority not submitted.
8. Notarized copy of Building Completion Certificate issued by competent authority not submitted.
9. A notarized copy of Change of land use (CLU) certificate submitted in the name of S.B. MULTIPURPOSE HUMAN DEVELOPMENT EDUCATION AND SOCIAL WELFARE SOCIETY, Chhatarpur, M.P.
10. Notarized copy of Non-Encumbrance Certificate issued by competent authority not submitted. (submitted photocopy)
11. FDRs as per NCTE Regulations, 2014 not submitted.
12. The name of the society does not match in the above documents.

AND WHEREAS, the reply was not submitted by the institution.

AND WHEREAS, the matter was placed before WRC in its 256th Meeting held on July 19-21, 2016 and the Committee decided that “...Show Cause Notice dt. 16/02/2016 was issued to the institution on the grounds of non-submission of notarized copy of approved building plan, Building Completion Certificate, CLU and Non-Encumbrance Certificate. There is a difference in name of the Society in the online application form and the documents submitted.

Since, no reply has been received to the Show Cause Notice, **Recognition is refused.**”

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to S.B. COLLEGE CHHATARPUR, PLOT NO- 88/2, 87/2, STREET- NOWGONG ROAD, VILLAGE- MUBASI, POST OFFICE- DHAMORA, TEHSIL- CHHATARPUR, CITY- CHHATARPUR, DISTRICT: CHHATARPUR- 471001, MADHYA PRADESH for B.ED. Course.
