**REFUSAL ORDER**

WHEREAS in terms of section 14 of the NCTE Act, 1993, **Girdhar Gopal Shiksha Prasar Evam Jan Kalyan Samiti, Plot no.: Ward32, Street/Road: Jawahar Marg, Vill.: Behind old gas agency, P.O.: Chhatarpur, Teh./Tal.: Chhatarpur, Town/City: Chhatarpur, Dist.: Chhatarpur - 471001, Madhya Pradesh** had submitted the application on **30.06.2015** to the Western Regional Committee of the NCTE for grant of recognition to **S. R. College, Plot no.: 428, Street/Road: NH 86, Vill.: Hama, P.O.: Chhatarpur, Teh./Tal.: Chhatarpur, Town/City: Chhatarpur, Dist.: Chhatarpur - 471001, Madhya Pradesh** for conducting the **B.A.B.Ed. 4 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 13.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in 241<sup>th</sup> meeting of the WRC held on February 04-06, 2016 it was decided as under:

*"The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notices to the rest. Action taken should be reported in the next meeting of the WRC."*

AND WHEREAS, the Show cause notice was issued on 12.02.2016.

AND WHEREAS, the decision of WRC in its 248<sup>th</sup> meeting held on April 11-12, 2016. The Committee decided that *"...The Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case be put up before the WRC on receipt of the VTR."*

AND WHEREAS, the Visiting Team visited the institution on 15.04.2016

AND WHEREAS, the visiting team report alongwith other documents, were considered by WRC in its 251<sup>st</sup> meeting held on April 30 - May 02, 2016. The Committee decided that *"... The VT visited the institution on 22/04/2016. The VT report was perused however, the CD could not be viewed. Hence, the institution be asked to submit a viewable CD."*

AND WHEREAS, the reply dated 01.05.2016 (As per minutes uploaded on WRC website) submitted by institution was considered by WRC in its 261<sup>st</sup> meeting held on October 26-28, 2016. The Committee decided that *"The case file was seen. The VT visited the institution on 22/04/2016 but the CD could not be viewed. Now the institution has submitted a fresh CD. The CD was seen and VTR perused. The CD shows a building with adequate infrastructural and instructional facilities. The VT has recommended the case. Hence, LOI be issued for two units of the B.A.B.Ed. course."*

AND WHEREAS, the Letter of intent was issued on 04.11.2016.

AND WHEREAS, the matter of reply not received was placed before WRC in its 279<sup>th</sup> meeting held on August 10-11, 2017. The Committee decided that "... LOI was issued on 04.11.2016. Till date no reply has been received. **Show Cause Notice be issued.**"

AND WHEREAS, the Show cause notice was issued on 18.08.2017.

AND WHEREAS, the matter of reply not received was placed before WRC in its 288<sup>th</sup> meeting held on February 15-16, 2018. The Committee decided that "...Consequent to the issue of LOI, Show Cause Notice was issued to the institution on 18.08.2017. Till date no reply has been received. **Hence, Recognition is refused.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to **S R College, Plot no.: 428, Street/Road: NH 86, Vill.: Hama, P.O.: Chhatarpur, Teh./Tal.: Chhatarpur, Town/City: Chhatarpur, Dist.: Chhatarpur - 471001, Madhya Pradesh** for the **B.A.B.Ed. 4 Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website [www.ncte-india.org](http://www.ncte-india.org).
