REFUSAL ORDER

WHEREAS. in terms of Section 14 of the NCTE Act, 1993, SATYAM SHIVAM SIKSHAN SANSTHAN, PLOT NO- 70, STREET- CHITRAKOOT ROAD, VILLAGE- MAJHGAWAN, POST OFFICE- SATNA, TEHSIL- RAGHURAJ NAGAR, CITY- SATNA, DISTRICT: SATNA- 485001, MADHYA PRADESH had submitted the online application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to SATYAM SHIVAM SHIKSHA MAHAVIDYALAYA, PLOT NO- 70, STREET- CHITRAKOOT, VILLAGE- MAJHGAWAN, POST OFFICE- SATNA TEHSIL- RAGHURAJ NAGAR, CITY- SATNA, DISTRICT: SATNA- 485001, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, Department of Higher Education. M.P., Bhopal vide letter dated 09.10.2015 has given the negative recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS. Show Cause Notice was issued to the institution on 15.02.2016 on the following points:-

- 1. Certified copy of land documents not submitted.
- 2. Notarized copy of Change of land use (CLU) Certificate issued by competent authority not submitted. A Xerox copy submitted which shows for nursery purpose.
- 3. No Objection Certificate from the affiliating body not submitted.
- 4. Notarized copy of Non-Encumbrance Certificate not submitted.
- 5. Notarized copy of Building Plan approved by competent authority not submitted.
- 6. Notarized copy of Building Completion Certificate not submitted.
- 7. Institution does not fulfill the condition as per clause 2 (b) and 3 (a) of NCTE Regulations, 2014 according to which every teacher training institution has to be composite institution.
- 8. FDRs as per NCTE Regulations, 2014 not submitted.

AND WHEREAS, the reply was not submitted by the institution.

AND WHEREAS, the matter was placed before WRC in its 256th Meeting held on July 19-21, 2016 and the Committee decided that "...Show Cause Notice dt. 15/02/2016 was issued to the institution on the grounds of non-submission of certified copy of land documents, notarized copy of building plan, Building Completion Certificate, CLU and Non-Encumbrance Certificate; and NOC from the affiliating body. Also, the institution is a standalone institution.

The Show Cause Notice has been undelivered, even though it was sent on the address given by the applicant.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to SATYAM SHIVAM SHIKSHA MAHAVIDYALAYA, PLOT NO- 70, STREET- CHITRAKOOT, VILLAGE- MAJHGAWAN, POST OFFICE- SATNA TEHSIL- RAGHURAJ NAGAR, CITY- SATNA, DISTRICT: SATNA- 485001, MADHYA PRADESH for B.ED. Course.
