**REFUSAL ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, SABKA PRAYAS JANHIT SAMITI, PLOT NUMBER - HOUSE NO.15, STREET/ROAD - WARD NO.1 INFRONT OF RELIANCE, VILLAGE - NOWGONG ROAD, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY/DISTRICT - CHHATARPUR, PIN CODE - 471001, MADHYA PRADESH (WRCAPP3431/222) had submitted on 30.06.2015 the application to the Western Regional Committee of the NCTE for grant of recognition to, PRAYAS EDUCATION COLLEGE, PLOT/KHASRA NO.240/1, STREET NUMBER - 07/09, VILLAGE - MAHANTPUR, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY/DISTRICT - DAMOH, PIN CODE - 470661, MADHYA PRADESH for starting the D.El.Ed. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 30.10.2015, 17.12.2015, and 08.01.2016 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, WRC in its 241<sup>st</sup> meeting held on February 4-6, 2016 decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be. Accordingly, Show Cause Notice was issued to the institution on 15.02.2016 on the following grounds:-

- Notarized copy of CLU/Diversion order not submitted.
- Notarized Copy of Building Completion Certificate not submitted.
- No Objection Certificate from the affiliating body not submitted by the institution.
- FDRs not submitted as per NCTE Regulations, 2014.
- As per records, the institution is not a composite institution.

AND WHEREAS, reply not submitted by the institution. The matter was placed before WRC in its 266<sup>th</sup> meeting held on January 10-12, 2016 and the Committee decided that "...Clarification letter/Show Cause Notice dt. 15/02/2016 was issued to the institution. Reply has not been received till date. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3)(b) of the NCTE Act, hereby refuses recognition to PRAYAS EDUCATION COLLEGE DAMOH, PLOT/KHASRA NO.240/1, STREETNUMBER - 07/09, VILLAGE - MAHANTPUR, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY/DISTRICT - DAMOH, PIN CODE - 470661, MADHYA PRADESH for the D.El.Ed. Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
