**REFUSAL ORDER**

WHEREAS in terms of section 14 of the NCTE Act, 1993, Th. Sawant Singh Ji Shiksha Evam Samaj Kalyan Samiti, Street/Road: Old UCO Bank Building, Vill.: Char Shahar Ka Naka, P.O.: Hazira, Teh./Tal. + City: Gwalior, Dist.: Gwalior 474003, Madhya Pradesh had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to D P Singh Shiksha Mahavidyalaya, Plot No. 12/11, 12/12, 12/14, Street/Road: A.B. Road, Vill.: Baraua, P.O.: Baraua, Teh./Tal.: Near Rairoo, City: Gwalior, Dist.: Gwalior 474010, Madhya Pradesh for conducting the B.A.B.Ed. 4 Years integrated programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 15.07.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in 241<sup>th</sup> meeting of the WRC held on February 04-06, 2016 it was decided as under:

"...The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC."

**Hence, in view of the above, Show Cause Notice was issued on 16.02.2016 on the following points:-**

1. Notarized copy of Non-Encumbrance certificate issued by Sub-Registrar not submitted.
2. Notarized copy of Change of Land Use certificate issued by Sub-Divisional Officer not submitted. Photocopy submitted. Diverted area is less as required.
3. Notarized copy of Registration, Memorandum, By-laws of the society/trust are not submitted.
4. Notarized copy of Building plan approved by competent authority not submitted. Photocopy submitted. Total built-up area is less.
5. Notarized copy of NOC from affiliating body not submitted.
6. Notarized copy of Building Completion certificate not submitted.
7. FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
8. The Institution is also directed to clarify for which course it has applied, i.e. for B.A.B.Ed or B.Sc.B.Ed.
9. Total Land area, Total Built up area & Total Diverted area is less as per NCTE norms.

AND WHEREAS, the reply of Show Cause Notice was received on 12.04.2016.

AND WHEREAS, the WRC in its 257<sup>th</sup> meeting held on August 02-04, 2016. Considered the matter and decided that "...This institution is already recognized for B.Ed. two units. Now the application is for one unit of B.A.B.Ed. course. The documents were examined. Show Cause Notice dt. 16/02/2016 was issued on the grounds of non-submission of:-

- i) Notarized copy of Non-Encumbrance Certificate;
- ii) Change of Land Use Certificate, with less diverted area;
- iii) Notarized copy of Registration and Memorandum bye-laws of the Society;
- iv) Notarized copy of approved Building Plan;
- v) Notarized copy of Building Completion Certificate;
- vi) FDRs;
- vii) Number of units of the applied for course; and
- viii) Total land area, total built up area and total diverted area being less.

The reply of the applicant was examined. It is seen that at the time of making the application itself, the documents for Khasra Nos. 63/1 and 63/8 were submitted, which total to 0.345 Hectares. Since, these two survey numbers were not mentioned in the application, they were not taken into account. The CLU for these survey numbers has also been submitted. The only issue is that it is not known whether these two survey nos. 63/1 and 63/8 are contiguous to the survey nos. 12/11, 12/12 and 12/14. The applicant needs to submit the Patwari Map for all the Khasra numbers alongwith the Map of the area so that contiguity of the lands can be ascertained. The new Building Completion Certificate is not certified by a competent Engineer. This can be done at the time of the VT, provided the applicant can clarify the position relating to land. **Clarification be obtained on this ground."**

AND WHEREAS, the Clarification letter was issued on 10.08.2016

AND WHEREAS, the reply received on 30.08.2016 of the Institution was placed before WRC in its 263<sup>rd</sup> meeting held on November 25-27, 2016. The Committee decided that **"....Clarification letter was issued on 10/08/2016 regarding contiguity of the plots and the reply was received on 23/08/2016.**

Now, Patwari Halka map has been submitted which shows that Plot no. 12 and Plot no. 63 are contiguous. **Since all the documents are in order, VT be constituted."**

AND WHEREAS, As per above decision, V.T. was constituted through online on 01.12.2016.

AND WHEREAS, the V.T. Member (Dr. Vineeta Singh) vide Email dt. 03.01.2017 has informed that **"...inspection did not take place because the college cancelled the inspection."**

AND WHEREAS, the matter was placed before WRC in its 283<sup>rd</sup> meeting held on November 14-15, 2017. The Committee decided that **"...VT was constituted vide letter dated 01.12.2016 but the institution refused inspection. Now, the institution has expressed readiness.**

**Hence, VT will be constituted on submission of fee of Rs.1.50 lakhs within one month, failing which the Recognition will be refused. Show Cause Notice be issued to the institution."**

AND WHEREAS, the Show Cause Notice was issued on 20.11.2017.

AND WHEREAS, the matter of reply not received was placed before WRC in its 288<sup>th</sup> meeting held on February 15-16, 2018. The Committee decided that **"....Show Cause Notice was issued to the institution on 20.11.2017. The institution has not replied till date. Hence, Recognition is refused."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to **D P Singh Shiksha Mahavidyalaya, Plot No. 12/11, 12/12, 12/14, Street/Road: A.B. Road, Vill.: Baraua, P.O.: Baraua, Teh./Tal.: Near Rairoo, City: Gwalior, Dist.: Gwalior 474010, Madhya Pradesh** for the **B.A.B.Ed. 4 Years** integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website [www.ncte-india.org](http://www.ncte-india.org).
