**REFUSAL ORDER**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, LATE SHRI GIRIJA SHANKAR EDUCATION AND DEVELOPMENT SOCIETY, PLOT NO- 81/5/2, STREET- JHANSI ROAD, VILLAGE- MAHUA BAG, POST OFFICE- MOHANGARH, TEHSIL- JATARA, CITY- TIKAMGARH, DISTRICT: TIKAMGARH- 472101, MADHYA PRADESH had submitted the online application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to SHRI PRAKASH CHANDRA MAHAVIDHYALAYA, PLOT NO- 81/5/2, VILLAGE- MAHUA BAG, POST OFFICE- MOHANGARH, TEHSIL- JATARA, POST OFFICE- MOHANGARH, CITY- TIKAMGARH, DISTRICT: TIKAMGARH- 472101, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 19.11.2015 has given the negative recommendation.

AND WHEREAS, the application of the institution was processed.

AND WHEREAS, Show Cause Notice was issued to the institution on 16.02.2016 on the following points:-

1. Notarized copy of Change of land use (CLU) certificate issued by competent authority not submitted.
2. Notarized copy of Non-Encumbrance certificate not submitted.
3. Notarized copy of Building plan by the competent authority not submitted.
4. Notarized copy of Building Completion Certificate not submitted.
5. Institution does not fulfill the condition as per clause 2 (b) and 3 (a) of NCTE Regulations, 2014 according to which every teacher training institution has to be composite institution.
6. FDRs as per NCTE Regulations, 2014 not submitted.

AND WHEREAS, the reply was submitted by the institution on 05.03.2016.

AND WHEREAS, the matter was placed before WRC in its 249<sup>th</sup> Meeting held on April 21-23, 2016 and the Committee decided that "... Show Cause Notice was issued to the institution on 16/02/2016. An examination of the reply shows that the institution has not as yet submitted notarized copy of Non-Encumbrance Certificate and Building Completion Certificate. further, it is seen from the file that the Society has not submitted the originally certified copy of land documents.

Hence, Clarification be obtained on the above grounds."

AND WHEREAS, Letter seeking clarification was issued to the institution on 26.04.2016.

AND WHEREAS, the reply was not submitted by the institution.

AND WHEREAS, the matter was placed before WRC in its 257<sup>th</sup> Meeting held on August 2-4, 2016 and the Committee decided that "...A letter dt. 27/04/2016 was issued to obtain Clarification. No response has been received.

Hence, Recognition is refused. FDRs if any be returned.

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to SHRI PRAKASH CHANDRA MAHAVIDHYALAYA, PLOT NO- 81/5/2, VILLAGE- MAHUA BAG, POST OFFICE- MOHANGARH, TEHSIL- JATARA, POST OFFICE- MOHANGARH, CITY- TIKAMGARH, DISTRICT: TIKAMGARH- 472101, MADHYA PRADESH for B.ED. Course.
