**Refusal Order**

Whereas in terms of section 15 of the NCTE Act, 1993, Shri Vedatryee Education Trust, Sardar Patel Park 1, B/h. Balaji Hall. 150 Feet Ring Road, Nr. Pathak School, Rajkot, Gujarat, had applied on 31.05.2016 in the Western Regional Committee, (NCTE), Bhopal for grant of recognition for conducting B.Sc. B.Ed. (Integrated) 4 Year Course.

And whereas, after scrutiny of the application file was placed before WRC in its 266<sup>th</sup> held on 10<sup>th</sup>-12<sup>th</sup> January, 2017, the Committee decided to issue Show Cause Notice dt. 17.01.2017.

And whereas, reply of Show Cause Notice was not received in the office till date And the case was placed in 271<sup>th</sup> meeting held on 23<sup>rd</sup> - 25<sup>th</sup> March, 2017 and committee was decided to issue refusal order to the institution on the following points:-


"The case file was seen. Show Cause Notice was issued to the institution regarding composite nature of the institution. The institution has not given any reply till date.

Hence, Recognition is refused u/s 14(3)(b) of NCTE Act, 1993."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, the **Western Regional Committee hereby refuses grant of recognition to Pathak Institute Of Teacher Education, Village: NR. Metoda GIDC, After Jyoti CNC Street/Road: Kalawad Road, Metoda, Khirasara (Ranmalji) Taluka/Mandal, District: Rajkot, State: Gujarat - 360035.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
