Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Shri Jivan Jyot Trust Village: Vaghela, Street/Road- Vaghela Road Taluka/Mandal- Wadhwan, City/District- Surendranagar, State- Gujarat, had applied on 30.05.2016 in the Western Regional Committee, (NCTE), Bhopal for grant of recognition for conducting B.A. B.Ed. (Integrated) 4 Year Course.

And whereas, after scrutiny of the application file was placed before WRC in its 266th held on 10th-12th January, 2017, the Committee decided to issue Show Cause Notice dt. 17.01.2017.

And whereas, reply of Show Cause Notice was received in the office on 17.02.2017 & the case was placed in 271th meeting held on 23rd - 25th March, 2017 and committee was decided to issue refusal order to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued on the ground that it is a stand-alone institution. That is running Shri Kalubapa PTC College which does not satisfy clause 2(b) of NCTE Regulations, 2014.

Hence, Recognition is refused u/s 14(3)(b) of NCTE Act, 1993."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, the **Western Regional Committee hereby refuses grant of recognition to Shri Jivan Jyot Mahila B.A.B.Ed. College, Village: Vaghela, Street/Road- Vaghela Road, Taluka/Mandal- Wadhwan, Town/City- Vaghela, District- Surendranagar, State-Gujarat**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order. The guidelines of appeal may be downloaded from the NCTE website.
