Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Shree Swaminarayan Samaj Seva Trust, Street/Road - Okha State Highway, NR. Civil Airport, Naghedi, Taluka/Mandal - Jamnagar, District - Jamnagar Corpn. - 361001, Gujarat, had applied on 30.05.2016 in the Western Regional Committee, (NCTE), Bhopal for grant of recognition for conducting B.Sc. B.Ed. (Integrated) 4 Year Course.

And whereas, after scrutiny of the application file was placed before WRC in its 266th held on 10th-12th January, 2017, the Committee decided to issue Show Cause Notice dt. 17.01.2017.

And whereas, reply of Show Cause Notice was not received in the office till date And the case was placed in 271th meeting held on 23rd - 25th March, 2017 and committee was decided to issue refusal order to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued to the institution regarding the name of the institution. The institution has not given any reply till date.

Hence, Recognition is refused u/s 14(3)(b) of NCTE Act, 1993."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to Shree Swaminarayan Gurukul B.Sc. B.Ed. College, Plot No. 01, Khasra No. R.S. no. 168/P1, Village - Naghedi, Street/Road - Khambhaliya Highway, nr. Civil Airport Road, Naghedi, Taluka/Mandal - Jamnagar, District - Jamnagar Corpn., Gujarat - 361001.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
