Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Sagar Education & Charitable Trust, Village - Visanvel (gadu), Street/Road - Gadu Chorvad Road, Nr. GEB Sub Station, Taluka/Mandal - Visanvel (Gadu), District - Junagadh - 362255, Gujarat, had applied on 31.05.2016 in the Western Regional Committee, (NCTE), Bhopal for grant of recognition for conducting B.Sc. B.Ed. (Integrated) 4 Year Course.

And whereas, after scrutiny of the application file was placed before WRC in its 266th held on 10th-12th January, 2017, the Committee decided to issue Show Cause Notice dt. 17.01.2017.

And whereas, reply of Show Cause Notice was received in the office on 21.02.2017 & the case was placed in 271th meeting held on 23rd - 25th March, 2017 and committee was decided to issue refusal order to the institution on the following points:-


"The case file was seen. The institution has submitted various land documents. However, DADHICHI INSTITUTE OF TEACHER EDUCATION is not a composite institution. The Society has informed that it is running an Arts college by the name of 'Shree Saurabh Arts College', Visanvel. Since the institution is not a composite one.

Hence, Recognition is refused u/s 14(3)(b) of NCTE Act, 1993."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, the **Western Regional Committee hereby refuses grant of recognition to Dadhichi Institute of Teacher Education Plot No. 453 paiky, Street/Road - Gadu Chorvad Road, near GEB Sub Station, Taluka/Mandal - Maliya Hatina, District - Junagadh, Gujarat - 362255.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
