REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SAMRAT CHANDRAGUPT MAURYA AADARSH SANSKRATIK EVAM LOKHIT JANKALYAN SOCIETY, PLOT NO- 154, STREET- MAHENDRA COMPLEX, ZONE-I, M.P. NAGAR, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462011, MADHYA PRADESH had submitted the online application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to SAMRAT CHANDRAGUPT MAURYA COLLEGE, PLOT NO- 50/1/1, STREET- BHOJPUR ROAD, VILLAGE- MEDUA, POST OFFICE- MANDIDEEP, TEHSIL- GOUHARGANJ, CITY- RAISEN, DISTRICT: RAISEN- 462046, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 22.09.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

- Blue Print/Notarized copy of Building Plan issued by competent authority not submitted.
- Certified copy of registered land documents issued by the competent authority as required under provision of section 8 (4) (i) of NCTE Regulations, 2014, not submitted.
- Notarized copy of Non-Encumbrance Certificate issued by competent authority not submitted
- Notarized copy of Building Completion Certificate issued by competent authority not submitted.
- FDRs as per NCTE Regulations, 2014, not submitted.

AND WHEREAS, the Show Cause Notice was issued to the institution on 18.02.2016 and the reply of Show Cause Notice was received on 17.03.2016.

AND WHEREAS, the reply was placed before the WRC in its 253rd Meeting held on May 24-26, 2016, the committee observed that:- "...The Society has applied for the B.Ed. course (APP3214) and for the D.El.Ed. course (APP3212). Show Cause Notice was issued on 18/02/2016 and reply was received on 25/02/2016. An examination of the documents shows that the institution has not submitted the notarized copy of Building Completion Certificate.

Secondly, as per building plan the built up area is only 2585 sq. mtrs. against the requirement of 3000 sq. mtrs. for one unit of the B.Ed. course and one unit of the D.El.Ed. course.

Hence, Clarification be obtained on the above grounds. "

AND WHEREAS, the Clarification letter was issued to the institution on 30.05.2016 and the institution has not submitted the reply till date.



NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **SAMRAT CHANDRAGUPT MAURYA COLLEGE, PLOT NO- 50/1/1, STREET- BHOJPUR ROAD, VILLAGE- MEDUA, POST OFFICE- MANDIDEEP, TEHSIL- GOUHARGANJ, CITY- RAISEN, DISTRICT: RAISEN- 462046, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
