REFUSAL ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, **TAKSHSHILA EDUCATION SOCIETY, 21 CIVIL LINE, PLOT NO.29/46, STREET/ROAD - NH-7, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY/DISTRICT: KATNI, PIN CODE: 483501, MADHYA PRADESH (WRCAPP2554/222)** had submitted the application on 30.04.2015 to the Western Regional Committee of the NCTE for grant of recognition to **NALANDA SCIENCE & COMMERCE COLLEGE, PLOT/KHASRA NO.29/46, PHN-1228/28,29, MAHARANA PRATAP JHINJHARI PLOT, STREET NO. NH-7, VILLAGE - JHINJHARI KATNI, TOWN/CITY/POST OFFICE/TEHSIL/TALUKA/DIST. KATNI, PIN CODE - 483501, MADHYA PRADESH** for **D.El.Ed** Course of 2 year duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 08.07.2015, 28.10.2015 and 09.12.2015 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, the matter was placed in 239th WRC meeting held on January 6-8, 2016 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 14.01.2016.

AND WHEREAS, reply received from the institution was placed in 241st WRC meeting held on February 4-6, 2016 and the Committee observed that "...Show Cause Notice dt. 14/01/2016 was issued to the applicant for submission of documents as required under NCTE Regulations, 2014. The applicant has again submitted only xerox copies of the documents - the land ownership document is not originally certified and the other documents also are not originally notarized. Further, the applicant has not submitted a Building Completion Certificate which is required under the Regulations. It is therefore not possible to verify the claim of the applicant that sufficient built up area is available for two units of B.Ed. and the proposed D.El.Ed. From the Building Plan and Building Permission, it is not possible to decide how much built up area is available. **Since, the applicant has not complied with the requirement of the NCTE Regulations, 2014. Recognition is refused.**"

NOW THEREFORE, the WRC, in exercise of powers vested u/s 15(3)(b) of the NCTE Act, hereby refuses recognition to **NALANDA SCIENCE & COMMERCE COLLEGE, PLOT/KHASRA NO.29/46, PHN-1228/28,29, MAHARANA PRATAP JHINJHARI PLOT, STREET NO. NH-7, VILLAGE - JHINJHARI KATNI, TOWN/CITY/POST OFFICE/TEHSIL/TALUKA/DIST. KATNI, PIN CODE - 483501, MADHYA PRADESH** for the **D.El.Ed.** Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
