Restoration order

WHEREAS, recognition was granted to the institution, namely, CRYSTAL SHIKSHA PRASAR SAMITI, SHRI KRISHNA COLLEGE, BHIND. OLD GOVT. DEGREE COLLEGE, NOWGONG ROAD, HARPALPUR, CHHATARPUR, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide order dated 28.07.2008 for an annual intake of 100 students.

AND WHEREAS, Shri Dayaram Choudhry filed W.P. No.6094/2014. (PIL) in the Hon'ble High Court at Jabalpur. The said W.P. was clubbed with the PIL filed by Shri Pawan Dubey, wherein the Hon'ble court had directed to conduct inspection of all B.Ed. institutions. The inspection of the institution was conducted u/s 13 by the NCTE Hqrs.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 26.03.2015.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 16.01.2015 and the reply was received on 18.01.2015.

AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on **31.05.2015**.

AND WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs. to the institution on 27.07.2015. The institution reply was not submitted.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 11.08.2016.

AND WHEREAS, the matter was placed in 260<sup>th</sup> meeting of WRC held on October 13-15, 2016 and the Committee decided that "... Deficiency letter was issued on 27/07/2015. However no reply has been received so far.

**Hence, Show Cause Notice be issued on the points of Deficiency letter. Reply should be submitted to the WRC within 15 days "**

AND WHEREAS, the Withdrawn order was issued by the WRC on 02.01.2017.

AND WHEREAS, appeal filed by the institution u/s-18 of the NCTE Act, 1993 Appeal No. APPL3655 dated on 15.02.2017.

AND WHEREAS, Appeal order dated 21-06-2017, Decision Direction of the Appellate Authority "...The committee, concluded that the appeal deserves to be remanded to W.R.C. with a direction to consider the appellant letter dt. 16.02.2017 and seek any further clarification/documents from the appellant and take further action as per the NCTE Regulation, 2014. In the meantime the withdrawal order shall be kept in abeyance.

**NOW THEREFORE, the Council hereby remands back the case of Shri Krishna Mahavidyalaya, Harpalpur, Chhatarpur, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.**

AND WHEREAS, the matter was placed in 283<sup>rd</sup> meeting of WRC held on November 14-15, 2017 and the Committee decided that "... Recognition was withdrawn because the institution has not submitted any documentary evidence regarding payment of salary to the staff through bank according to approved pay scales and extension of benefits regarding EPF/CPF. The institution went in appeal. The appeal has remanded the case to WRC to further process the case.

The institution is provided one more opportunity to submit the evidences/documents as required, failing which withdrawal order will stand.

**On receipt of the above documents, the case will be processed further. Reply should be submitted within one month."**


AND, WHEREAS, letter seeking Clarification was issued to the institution on 17.11.2017 and reply was received 15.12.2017.

AND WHEREAS, the matter was placed in 285<sup>th</sup> meeting of WRC held on December 19-21, 2017 and the Committee decided that "... In response to the clarification letter dated 17.11.2017, the institution has sent compliance vide letter dated 15.12.2017.

**The institution is still to submit FDRs for Rs.12.00 lakhs in joint name. As soon it is received, Recognition is restored."**

AND WHEREAS, the Clarification letter was issued to the institution on 19.01.2018 and reply was received from the institution on 15.02.2018. with original joint FDRs of Rs. 5+3+4 = 12 Lakhs.

NOW THEREFORE, the recognition of CRYSTAL SHIKSHA PRASAR SAMITI, SHRI KRISHNA COLLEGE, BHIND. OLD GOVT. DEGREE COLLEGE, NOWGONG ROAD, HARPALPUR, CHHATARPUR, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) is hereby restored.
