Regulation 5(3) of NCTE Regulations, 2014 mandates that the application shall be submitted online along with processing fee and scanned copies of required documents such as No-objection Certificate issued by the concerned authority. Since the institution has not submitted the NOC, hence, the application be rejected."

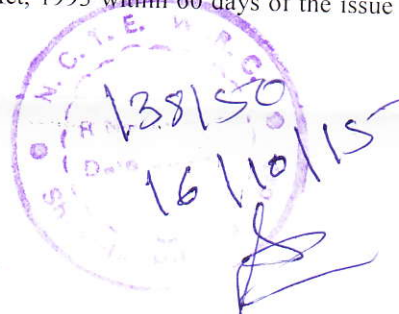
In view of above, the application of your institution for B.A.B.Ed./B.Sc.B.Ed. Integrated course is hereby rejected.


