The matter was placed before the WRC in its 233<sup>rd</sup> meeting held on October 8-9, 2015. The Committee decided as under:-

*"..... The institute has submitted the hard copy of the application after 15 days from the date of online application. The institute has also submitted application without NOC from the affiliating body.*


*Hence, as per provision of clause 7 of NCTE Regulations, 2014 the case be summarily rejected."*

In view of above, the application of your institution for D.P.S.E. course is hereby rejected.

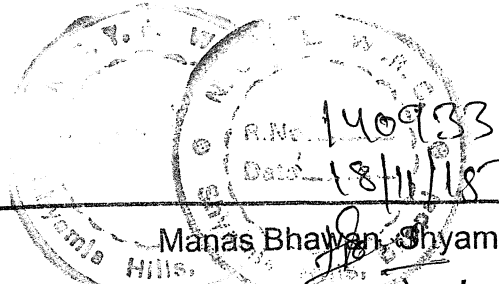
