In view of above, the application of your institution for B.Ed. Course is hereby rejected.

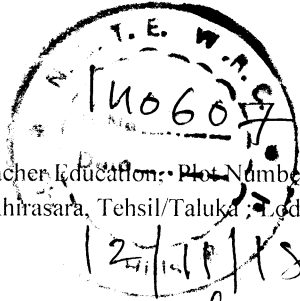
