Restoration of Recognition

Whereas, recognition was granted to Kadva Patel B.Ed. College, C/O J.B. Vidhalya, Gothra Compound, Taluka – Vishnagar, Mehsana, Gujarat - 384315 (code no. APW00579/323176) under section 14 of NCTE Act, 1993 for conducting B.Ed. course of one year duration with an annual intake of 100 students vide order no. No. WRC/5-6/92nd (Ext.)/2007/C-18819-18826 dt. 05.07.2007.

And whereas, the matter was considered by the Committee in its 120th meeting held on June 23-24, 2009 and having taken into consideration all the relevant facts of the case, it was decided to withdraw recognition given for conducting B.Ed. course with an annual intake of 100 students, order no. WRC/APW00579/323176/120th/2009/57339-57344 dt. 10.07.2009. Accordingly withdrawal order no. WRC/APW00579/323176/120th/2009/57339-57344 dated 10.07.2009 was issued to the institution.

And whereas, against withdrawal order, the institution preferred an appeal u/s 18 of NCTE Act, 1993 and the Appellate Authority vide order no. 89-813/2009 Appeal dt. 31.05.2010 accepted the appeal was accepted and WRC's order dated 22-12-09 was reversed with a direction to the WRC to restore the recognition granted to the institution within 15 days of issue of this order.

And whereas, a Corrigendum dated 26.08.2015 was issued by NCTE regarding correction in the file number of the institution.

And whereas, the matter was considered by the WRC in its 232nd meeting held on 16-17th September, 2015 and the Committee decided to restore recognition of the institution in view the direction given by the Appellate Authority for restoration of recognition.

Now therefore, the recognition of **Kadva Patel B.Ed. College, C/O J.B. Vidhalya, Gothra Compound, Taluka – Vishnagar, Mehsana, Gujarat - 384315** for given conducting B.Ed. course of one year duration with an annual intake of 100 students **which was** withdrawn by this office order no. WRC/APW00579/323176/120th/ 2009/ 57339-57344 dt. 10.07.2009, is hereby restored for conducting B.Ed. Course of two years duration with an annual intake of 100 students.


