ORDER

WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, RUN BY SHRI SANT KARTAR SINGH KALYAN SAMITI, NEHRU COLONY, THATIPUR, GWALIOR -474011, MADHYA PRADESH for D.EL.Ed. course vide order dated 14.08.2008 for an annual intake of 50 students.

AND WHEREAS, the institution applied under clause 8(9) of NCTE Regulations 2014, for change of premises of D.EL.Ed. course from SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, RUN BY SHRI SANT KARTAR SINGH KALYAN SAMITI, NEHRU COLONY, THATIPUR, GWALIOR -474011, MADHYA PRADESH to SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, SURVEY NO.552, VILL. PURASANI, THATHIPUR, DIST. GWALIOR, MADHYA PRADESH.

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 18.01.2016

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 242nd Meeting held on February 11-13, 2016. The Committee decided as under:-

"...This is a case of shifting. The CD was seen and the VT report perused. The CD shows adequate instructional and infrastructural facilities The VT has recommended the case. Hence, shifting is permitted. The attention of the institute be drawn to Clause 2(b), 3(a) and 8 (1) of the NCTE Regulations, 2014, for compliance, since Teacher Education Institutions have to be composite."

NOW THEREFORE, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises from SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, RUN BY SHRI SANT KARTAR SINGH KALYAN SAMITI, NEHRU COLONY, THATIPUR, GWALIOR -474011, MADHYA PRADESH to SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, SURVEY NO.552, VILL. PURASANI, THATHIPUR, DIST. GWALIOR, MADHYA PRADESH with immediate effect for conducting D.EL.Ed. course of two years duration with an annual intake of 50 students. The institution has to be a composite institution gradually preferably by 2016-2017.

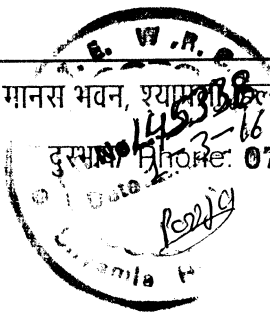
