I am to inform you that the case of your institution for **B.Ed.** Course was placed before the WRC in its 263rd Meeting held on November 25-27 and the Committee decided as under:

"... Show Cause Notice was issued to the institution on 12/05/2016 on the ground that the areas of Library and multipurpose hall were small and there were only 1373 books in the Library.

The institution by way of reply sent bills for acquisition of books. However, the new CD submitted by the institution does not seem to show an increase in the area of Library and multipurpose hall.

The institution is required to send revised Building Plan and revised Building Completion Certificate signed by Govt. Engineer. The new Building Plan should show how the increase has been made.

Further, an examination of the documents show that the Building Plan, CLU, and Non-Encumbrance Certificate are not notarized.

The CD shows that all the rooms are earmarked with temporary paper signs.

Compliance in the above matters should be submitted within 30 days."

In view of the above, you are requested to submit a reply within one month from the date of issue of this letter.

In the event of this office not receiving any representation within **one month** of the issue of this letter, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
