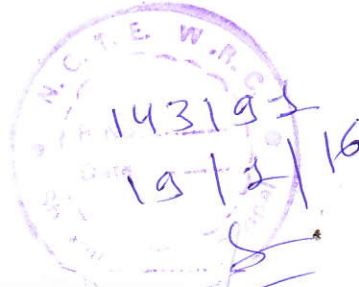
The case of the institution was placed before the WRC in its 232nd meeting held on 16-17th September, 2015 The Committee decided as under:

"The case file was seen. The institution has submitted online application without No-objection Certificate issued by the affiliating body. Regulation 5(3) of NCTE Regulations, 2014 mandates that the application shall be submitted online along with processing fee and scanned copies of required documents such as No-objection Certificate issued by the concerned authority. Since the institution has not submitted the NOC, hence, the application be rejected."

Accordingly, letter no. WRCAPP3209/B.A.B.Sc./232nd /MP/2015-16/153362-153363 dated 30.09.2015 was issued to the institution.

The WRC in its 234th meeting held on 03-05 November, 2015 decided to issue Show Cause Notice in all such cases where the institution did not submit the NOC of the affiliating body and their case was rejected.

In view of the decision of the WRC taken in 234th meeting, the letter no. WRCAPP3209/B.A.B.Sc./232nd /MP/2015-16/153362-153363 dated 30.09.2015 issued to the institution stands cancelled. The file of the institution is under further process.
