**ORDER**

WHEREAS, recognition was granted to the institution namely, J.B. INSTITUTE OF TEACHER EDUCATION, RUN BY PRAYAS SHIKSHA PRACHAR PRASAR EVAM SAMAJ KALYAN SAMITI, MORAR, GWALIOR-474006, MADHYA PRADESH under section 15(3)(a) of NCTE Act, 1993 for conducting D.ED course of two years duration with an annual intake of 50 students vide order dated 04.08.2009.

AND WHEREAS, institution had applied for shifting of premises on 17.05.2012.

AND WHEREAS, the deficiency letter was issued to the institution on 22.06.2012.

AND WHEREAS, the reply received from the institution was placed in the 178<sup>th</sup> meeting held on January 22-24, 2013 and the Committee decided that "...This is a case of shifting. The institution has not submitted notarized CLU, building completion certificate and non-encumbrance certificates. Hence, Show Cause Notice be issued to the institution on the above grounds." Accordingly, Show Cause Notice issued on 09.02.2013.

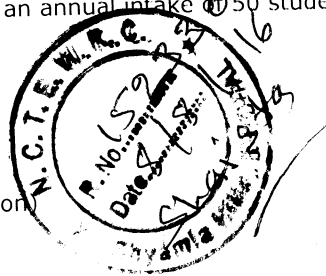
AND WHEREAS, the reply not submitted by the institution. The matter was placed in the 187<sup>th</sup> meeting held on July 25-26, 2013 and the Committee observed that "...From perusal of the file, it is noticed that the Show Cause Notice dated 09.02.2013 was sent at the Society's address and not to the institution, even though the letter is addressed to the Principal. Hence, there is a doubt that the Show Cause Notice may not have reached the institution. Hence, it is directed that the Show Cause Notice be sent to the Principal at the proposed new address and a copy of the letter be sent to the President/Secretary of the Society as available from the letter head of the Society on the file." Accordingly, again Show Cause Notice issued on 08.08.2013.

AND WHEREAS, the reply not submitted by the institution. The matter was placed in the 256<sup>th</sup> meeting held on July 19-21, 2016 and the Committee observed that "...This is a case of shifting. Show Cause Notice dt. 09/02/2013 was issued for submission of notarized CLU, Building Completion Certificate and Non-Encumbrance Certificate. When the case was considered in the 187<sup>th</sup> meeting, it was decided to issue another Show Cause Notice at the proposed new address, to ensure that the Show Cause Notice dt. 08/08/2013 is received. Still no reply has been received, even after two Show Cause Notices. **Hence, the application for shifting is rejected. Simultaneously, Show Cause Notice be issued as to why Recognition should not be withdrawn for both the courses.**"

NOW THEREFORE, permission under clause 8(9) of NCTE Regulation, 2014, is hereby rejected for change of premises from J.B. INSTITUTE OF TEACHER EDUCATION, RUN BY PRAYAS SHIKSHA PRACHAR PRASAR EVAM SAMAJ KALYAN SAMITI, MORAR, GWALIOR - 474006, MADHYA PRADESH to J.B. INSTITUTE OF TEACHER EDUCATION, PLOT NO.- 95, VILLAGE- KEDARPUR, POST OFFICE - I.T.M (SITHOLI), TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT- GWALIOR, PIN CODE- 474001, MADHYA PRADESH for conducting D.EL.Ed. course of two years duration with an annual intake of 50 students.
