These statements should be duly signed by the Bank Manager. **Compliance to the above be submitted within 15 days.**

Secondly, the complainant is also required to send documentary evidence for the complaints that he has made against the institutions as well as the office of the NCTE, Bhopal."

In view of the above, you are requested to submit the para-wise reply as mentioned in the complaint and as decided by WRC, alongwith supporting documents within 15 days from the date of this letter.
